5. Acceptance

MMTC Limited reserves the right either to accept / reject any offer at its discretion. After offers are opened, sale may be postponed or cancelled or MMTC Limited at its discretion can hold a limited auction amongst Tenderers who have offered bids. MMTC also reserves the right to further negotiate with highest bidder. Highest successful tenderer(s) will have to deposit 25% of the final bid on the spot before leaving the MMTC premises. The balance payment as decided after negotiation shall be paid within three working days failing which the EMD and 25% of the bid shall be forfeited. It is therefore necessary that all tenderers should be present at the time of opening of the price bid at MMTC on **2nd April, 2019 at 3.30 PM.**

6. Tax / Insurance etc.

All applicable Taxes except road taxes will be levied by MMTC Limited and Payable by the bidder over and above the bid price.

7. Possession.

Sale letter will be issued only in the name of Tenderer under which offer is made. Vehicle should be removed from MMTC Premises within four days from handing over sale letter. In case vehicle is not removed after four days demurrage will be charged at the rate of Rs. 200/- per day per vehicle and after 15 days MMTC Limited at its discretion may confiscate the amount deposited & dispose the vehicle in the best interest of MMTC Limited. No complaint will be entertained in this matter.

It will be responsibility of purchaser to get vehicle transferred in his name, N.O.C. if necessary will be given by MMTC.
