Definitions

- **SELLER:-** Seller referred in this catalogue, is MMTC Limited.(MMTC)
- **SERVICE PROVIDER:**
M/s. e-procurement Technologies Limited, B 705, Wall Street - II, Opp - Orient Club, Nr. Gujarat College, Ellis Bridge, Ahmedabad - 380006, Gujarat State, India (hereinafter referred to as “M/s e-procurement Technologies Limited,”) is an e-auction service provider appointed by the seller to facilitate virtual auction by the seller. **M/s e-procurement technologies Limited** will only facilitate online auction and are considered as third party not particularly interested in the item/s being sold on behalf of seller.

- 1.2 SELLER reserves the right to modify and amend the terms & conditions and announce the same at any time before the auction concludes. Announcements during the auction on the website including announcement of any additional conditions OR correction in the catalogue and/or additions or deletions of items being offered for sale are being done with the consent and knowledge of the seller, and it is binding on the bidder.
- 1.3 SELLER reserves the right to decrease or increase the quantity to any extent.
- 1.4 Participation and bidding in this Auction shall be treated as conclusive evidence of the fact that the bidder has inspected the Auction items and the documents pertaining to it and is satisfied in all respects regarding quantity, quality, condition of the Auction items, taxes and duties, and other extraneous factors and the Principle of Caveat Emptor (let the buyer beware) will apply. 2. “Notwithstanding anything contained in this agreement, MMTC’s policy for Holiday-Listing of an Agency mutatis mutandis applies to this agreement and in the event, the agency(s) while discharging its obligations under the Agreement or otherwise, come(s) within the ambit of the said policy, MMTC at its sole discretion reserved the right to suspend/discontinue dealings or take any curative measures with the agency(s) in accordance with the policy in force”.

PARTICIPATION

The prospective bidder has to register with **M/s e-procurement Technologies Limited**; the prospective bidder shall have to deposit Earnest Money Deposit (EMD) for each lot separately or for all lots as prescribed. 3.0 CONDITIONS APPLICABLE TO “ONLINE” AUCTION METHOD OF BIDDING.

3.1 **Validity:** The Online auction bidders and Tender bidders must keep their bids valid for a period of 30 (thirty) calendar days from the date of closing of e-Auction excluding the date of closing. In case the 30th day falls on a holiday or remains closed for the seller, such Bids will be deemed to be automatically extended to be valid up to the next working day of seller.

3.2 **Time Extension:** If any market-leading bid (bid higher than the highest at the point in time) is received within the last 05 minutes of closing time, the time will be extended automatically by 05 minutes.

3.3 **Bids:** All bids placed are legally valid bids and are to be considered as bids from the bidder himself. Once the bid is placed, the Bidders cannot reduce or withdraw the bid for whatever reason. If done so, the seller will forfeit the EMD. The highest and the latest bid on the Auction shall supersede all the previous bids of the bidder.

4.0 Payment

9.0 **DELIVERY**

- 9.1 The sale of Material (BFG Slag) shall be on Ex-Plant and on **“As is Where is and on No Complaint Basis”**.
- 9.2 It is also clarified that the BFG Slag offered through E-Auction is for **DOMESTIC SALE ONLY**.
- 9.3 Despatch of material is allowed by Rail only.
- 9.4 Invoicing will be done on actual weight registered at Motion Rail Weighbridge of NINL. However, rail freight will be charged at actual as per RR on chargeable weight basis. The excess payment relating to railway freight by the bidder will be refunded / adjusted after the transaction.
- 9.5 Quantity registered at Motion Rail Weighbridge of NINL shall be treated as final and binding to both seller and buyer for making payment and dispatch documents.
- 9.6 Unit of measurement for invoicing would be Metric Ton (MT).
- 9.7 The Analysis Report/Certificate issued by NINL on the quality of BFG Slag shall be treated as final and binding on the Buyer.
- 9.8 All supplies / deliveries shall be subject to availability of stock.
- 9.9 Railway freight in case of rail movement to be paid in advance to MMTC for placing indent with railways. The excess payment relating to railway freight paid by the customer will be refunded / adjusted after the transaction.
- 9.10 MMTC reserves the right to withdraw/review this E Auction at any time without assigning any reason(s) thereof.
- 9.11 No return and no claim after despatch of material shall be entertained by the Seller.
- 9.12 On receipt of full sale value including applicable GST, other levies, charges etc., MMTC will issue Delivery Order (D.O.) to the Buyers thereby enabling them to lift the material within the period specified in the D.O.
- 9.13 Successful bidders should ensure that the material clearance is as per the seller's instructions. Neat and clean maintenance of the stockyard from where the material is lifted is the responsibility of the successful bidder. In the event of non-adherence to the above by the successful bidder, seller will reserve its rights to impose penalties/forfeiture of Security Deposit (SD). Weight recorded at the seller's weighbridge shall be treated as final.
- 9.14 **In case a party bids for multiple lots for same items, the lifting of materials to start from the lots against which the party has quoted the highest bid and then move on to the next lowest bid lots. Defaulters will not be allowed to participate in two succeeding tenders.**

- 9.15 In case Seller is unable to deliver the goods within the specified time due to unforeseen administrative reasons, then the seller shall grant suitable extension of delivery period to the Buyer without any penalties till the expiry of such extended period. In such eventuality, however, the Buyer shall not be entitled to claim any compensation for such delay.
- 9.16 While taking delivery of the material, it will be at the discretion of the seller or its authorized representative to direct the manner / order in which the materials or lots shall be removed. Items offered for sale in lot shall be delivered / lifted completely without leaving anything on the ground.
- 9.17 The buyer shall arrange for all tools and tackles, forklifts and hoists or cranes or labour at their own expenses, if required, only for the items against which loading is in buyer's scope.
- 9.18 **Once the goods/materials are taken out of the factory gate, purchaser will be solely responsible for all sorts of claims like shortage, missing parts, damage, incident, accident, loss of material etc.**
- 9.19 **Determination of Weight :** The weight of the Materials delivered on ex-plant basis shall be as per NINL Weighment Scale.
- 9.20 Purchaser and his men are subject to the security rule of seller in force while in the seller's premises. The purchaser/s, their workmen agents or representatives shall not commit any nuisance, theft or indulge in any antisocial activities in the seller's premises and the purchaser shall be liable for the good conduct, safety & discipline of his workmen. In case of any such activity, delivery will be suspended and strict action as per law will be taken including forfeiture of SD.
- 9.21 While taking delivery of the material, the Purchasers shall be responsible for any damage that may be done to premises/fittings of the SELLER in the course of removing the lot or lots purchased by them. The SELLER may at its option arrange to make good such damages and the purchaser shall pay for the same on demand. If such payment is not made on demand, the SELLER may forfeit the Security Deposit or may stop delivery of the material till payment is made.
- 9.22 SELLER will not at any time be responsible for any injuries caused due to accident within its premises either to the buyer or his representative / labour etc., and the buyer will make proper arrangements for any claim arising out of the employment under any statute. It is the responsibility of the buyer to provide necessary safety appliances (like hand gloves / safety shoes etc.) to the labourers, who are engaged for loading the materials, if required.
- 9.23 If any accident or damage to the property / life etc. arises by reason of any act of negligence / omission / default or non-compliance with any of the Terms & Conditions or statutory regulations or rules and regulations applicable within the Seller's premises, on the part of the Buyer / his representative or employees, resulting in death or injury to any persons or damages to the property of the SELLER or any third party, then in such an event the Buyer will have to pay compensation to such person including the employees of the SELLER for such accident or injury / death or damage caused to their employees or to any of the Seller's employees or to others or to the Seller's property. The Buyer shall in such event, keep the SELLER fully indemnified from any demand, claims or proceedings thereof.

10.0 **Arbitration**

All disputes arising between the parties (Purchaser and Seller) out of or in relation to the work order shall be settled amicably. If, however, the parties fail to resolve amicably, the same shall be referred to and settled through an arbitration proceeding of a single/sole arbitrator, to be nominated by CMD, MMTC. The arbitration proceeding shall be conducted in accordance with the arbitration and conciliation Act 1996. The reasoned award made in pursuance thereof shall be binding on the parties, the venue of arbitration shall be New Delhi. Only the courts at New Delhi shall have the jurisdiction over the disputes in relation to and arising out of the work order.
