<u>5</u>	1.8: The Bidders blacklisted/banned//barred/terminated on account of non performance by any Central/State Govt. Department/PSU /Government Authority in the field of E-Procurement services during the last three years are not eligible. Undertaking to be submitted in the prescribed format- Annexure-II.	It is understandable that requirement of a undertaking is adequate to establish the credibility of the Bidder as on date of submission of this tender, However the requirement of providing an undertaking of past three years is inadequate and unreasonable which will seriously distort the competition expected in this bidding process.
