MMTC Limited, A Government of India Enterprise, Sub Regional Office at Kalinga Road, Barbil, Keonjhar Odisha Pin - 758035 (herein after called Seller) invites bids for sale of one 60 MT Avery make Electronic Road Weighbridge along with weights on 'as is where is' and 'no complaint' basis for which the reserve price is Rs.6,00,000/- excluding taxes. The sealed offer (Price Bid as per Annexure I) alongwith EMD in the form of DD/Bankers cheque payable at Barbil drawn in favour of MMTC Limited and Mandatory Information as per Annexure-II should be addressed to the Addl. General Manager at the above address which should reach by 13:30 Hours of 14/10/2015. Bidders shall submit their bids in a sealed envelope in the tender box kept in the office of the MMTC Ltd, Sub-Regional Office, Commodity Division, Barbil.

04. EMD details : Rs. 10,000/- in form of DD Favouring MMTC Limited, Payable at Barbil

05. Bidder : Any person - as an individual/proprietor or Partner or Company who is paying the requisite EMD for the purchase, is considered as bidder. Successful bidder is one in whose name confirmation of sale is issued by the seller. The successful bidder shall arrange on his own dismantling of Weigh bridge and shift the same within one month of confirmation of H-1 bidder . In the event of failure on the part of the successful bidder (H-1) to fulfil his contractual obligation, the seller reserves the right to debar such bidder from participating in any tender by the Seller and EMD shall be forfeited. Interested bidders will have to submit any of the following documents along with their bid:

06. Payment : MMTC Barbil shall issue invoice and receive payment. The H-1 bidder shall deposit the value plus applicable taxes within 7(seven) days from the confirmation of the H-1 bid by MMTC Limited in form of DD/Banker's Cheque/Pay Order favouring MMTC Limited payable at Barbil, or RTGS/NEFT SBI A/C No. 11192675029, IFS Code SBIN0002011. MMTC shall collect full applicable tax i.e. VAT/CST @ 5% on bidding price quoted.

07. Delivery :

- 7.1. On receipt of full sale value and applicable Tax the seller will issue sale order to successful bidder to lift the weighbridge.
- 7.2. While taking delivery of materials the buyer shall arrange all tools, cranes and labour, statutory declaration/clearances at their expenses.
- 7.3. Seller will not at any time be responsible for any injuries to anybody caused due to accident who are engaged for dismantling work.
- 7.4 The buyer shall make all arrangements at his own cost to make the vacant site in order, so that no complains is raised by any authority or local residents.

08. Arbitration : Any dispute or difference whatsoever, arising between the parties out of or relating to the construction, meaning, scope, operation of this contract or the validity or the breach thereof shall be settled by Arbitration by Sole Arbitrator to be nominated by The General Manager, MMTC, Bhubaneswar. The provision of arbitration and conciliation Act, 1996 shall apply to such arbitration proceedings. The venue of the Arbitration shall be Bhubaneswar, Odisha (India).

09. Mandatory Information : To be submitted alongwith the tender as per prescribed format at Annexure-II. The bid shall be rejected forthwith in case of non-receipt of this information alongwith the tender documents.

The tender shall be opened at 15:30 hours on the same date at Sub-Regional Office, Barbil, PO-Barbil, Dist Keonjhar (Odisha). VAT will be charged extra as applicable. MMTC reserves the right to accept/reject any or all the tenders without assigning any reason. EMD shall be refunded to unsuccessful bidder. The H-1 bidder must submit the value along with VAT as per following Performa (Annexure –I) within 27/10/2015 and arrange for shifting of the Weighbridge within 08/11/2015.

MMTC reserves the right to cancel or reject any or all bids without showing any reason whatsoever and the decision of MMTC in this respect shall be final and binding and shall not be liable to be questioned in any court or before any authority.
