In case of delivery by rail, freight will be charged as per RR on the basis of chargeable weight. Any other charges from Railways such as Demurrage, Punitive charges etc. shall be to Buyer's account.
- 2. The above prices are exclusive of GST, Railway/Road Freight and Other Statutory duties/levies/taxes etc.
- 3. Sale shall be made on first-come-first-serve basis. Railway indent or loading of trucks will be based on the sequence of payment received. Payment should be made till 1630 Hrs on 16 Nov., 2018.
- 4. Material will be dispatched against receipt of 100% value of the material along with freight, wherever applicable.
