4. Sale will be made on first cum first serve basis on receipt of 100% payment in MMTC account.
5. The decision of MMTC regarding allocation of material shall be final and binding without any prejudice.
6. All supplies / deliveries are subject to availability of stock.
7. Material will be despatched against 100% value of the material along with freight, wherever applicable.

10. The price shall be treated as firm irrespective of the price prevailing on the day of actual delivery.

12. The buyer has to bring a proper hose with end fitting matching to the fitting at plant and should have valid necessary licence for the purchase. The tanker and the crews should comply with applicable statutes and safety norms. Necessary loading facilities are available at site
13. The Liquid Oxygen, Liquid Nitrogen and Liquid Argon will be sold on metric tons basis and will be delivered through tankers only.
14. The weight of materials delivered on ex-plant basis shall be as per NINL weighment scale.
