#### **SPECIFICATION OF SILVER MEDALLION**

MMTC requires 10000 (+-10%) pcs of Silver medallions for MMTC of 400 gm (+- 10%) weight for its office **MMTC Limited Delhi Regional office, Jhandewalan New Delhi**.

- 1. The design of the coin will be provided by MMTC only but the die has to prepared by the fabricator/manufacturers.
- 2. The exact diameter and weight will be specified in Job order.
- 3. The total value of the stock to be manufactured is Rs 25 crores approx.
- 4. The supplies shall be made by the Fabricator within time prescribed by MMTC. Fabricator accepts that the time of supply specified in the order placed on him by MMTC shall be the essence of the contract. The issuing of around 4400 kg of old silverware will be completed till 10 September, 2014 and the entire finished product needs to be delivered till 25 September, 2014. In case, the Fabricator fails to deliver the articles within time mentioned in the order, he shall be liable to pay damages to MMTC which shall be @ 0.5% of the total stock value of Rs 25 crore approx per week subject to maximum of 5%

#### ANNEXURE II

#### Criteria for Empanelment of Silver Medallion fabricator for 2013-14

- > The fabricator must have their own refining and manufacturing unit
- MMTC reserves the right to inspect the manufacturing unit and verify any of relevant documents.
- MMTC shall place on fabricator order(s) for manufacturing of such medallions out of silver, which it so wishes, along with necessary specifications and samples. The silver, which shall be handed over by MMTC to the fabricator, shall be of 999.0 fine silver or any other stock of different purity.
- The silver, which shall be handed over by MMTC to the fabricator shall be property of MMTC and shall remain in trust with him.
- The Fabricator/Suppliers need to supply the fabricated material to MMTC Jhandewalan Office, having address, MMTC Limited, F 8-11, Jhandewalan Flatted Factories Complex, Rani Jhansi Road, New Delhi or any other location agreed by MMTC within NCR.
- The fabricator shall manufacture and supply medallions/bars as ordered/selected by MMTC out of the silver taken by him from MMTC;
- The acceptance of the quotation/offer will rest with the MMTC Limited who does not bind to accept the lowest quotation and reserves the right to reject or partially accept any or all the quotations received or to waive off any condition without assigning any reason.
- Price need to be quoted per medallion basis including all melting, refining, fabrication, transportation and all other related charges. Taxes on the supplied item need to be quoted separately.
- The medallions/bars fabricated shall be as per specifications as well as sample shown and finalized by MMTC and articles fabricated by him shall be of high quality;.
- The rates quoted will be valid for one year from the date of placing the order or may be extended further/reduced at the sole discretion of MMTC
- Payment will be made on per meallion basis on total quantity of fabricated material received by MMTC and after satisfactory assaying reports received by MMTC. Assaying can be done through MMTC assay centre or 3<sup>rd</sup> party inspection
- > The price bid of only those parties will be considered who have successfully cleared the technical bid.

- Party emerging as L-1, after issue of Job order always needs to submit a sample for individual orders and get approved by MMTC before start of work
- MMTC and/or its nominated officers will be entitled to inspect the articles while the same are in the process of fabrication;
- > The Fabricator shall render an account of the silver which is taken by him from MMTC;
- > The Fabricator shall follow the input and output norms as under: -

<u>INPUT</u>	<u>OUTPUT</u>
0 0	The Fabricator will supply 925 Grams of finished silver medallion of 999 fineness purity.

- Finished goods not confirming to the desired purity will be rejected and defaced before returning to the Fabricator. No charges of any sort will be paid to Fabricator.
- > The medallions/bars fabricated along with the balance silver, if any, shall be delivered at his own cost, by the Fabricator at the place specified by MMTC.
- Fabricator/Supplier needs to furnish BG of 110% of the value of silver issued to the party for fabrication of silver medallions on demand of MMTC. The quantity of silver to be issued in single lot will be decided by MMTC management from time to time considering the total quantity of medallions to be supplied. =
- The supplies shall be made by the Fabricator within time prescribed by MMTC. Fabricator accepts that the time of supply specified in the order placed on him by MMTC shall be the essence of the contract. The issuing of around 4400 kg of old silverware will be completed till 10 September, 2014 and the entire finished product needs to be delivered till 25 Septemebr, 2014. In case, the Fabricator fails to deliver the articles within time mentioned in the order, he shall be liable to pay damages to MMTC which shall be @ 0.5% of the total stock value of Rs 23 crore approx per week subject to maximum of 5%
- MMTC will be entitled to cancel the order and on such cancellation he shall return the silver and the medallions/bars by him to MMTC. Fabricator further accepts that he shall not be entitled to any claim of damages and/or any other relief from MMTC;
- Only those medallions/bars, which comply with the design, specifications prescribed by MMTC and are of the purity agreed to and referred to above, shall be acceptable to MMTC. The decision of MMTC in this respect shall be final. The Fabricator shall be paid only for those medallions/bars, which have been accepted by MMTC.

- ➢ Fabricator will undertake to reimburse and indemnify MMTC of all damages incurred by MMTC in case any third party to whom any article fabricated by the Fabricator is sold/supplied by MMTC is found to be defective and/or have purity less than the declared.
- Participants should provide their price bid in prescribed format with utmost care. They should use their company letterhead and put their signature along with the rubber stamps of the company. All crossing/cutting should be signed. No overwriting is allowed.
- Fabricator will agree all the terms and conditions of the agreement to be entered into with MMTC fabricator panel and should sign and stamp all the 09 pages of Technical bid and 01 page of price bid.
