

NOTICE INVITING TENDER

Sub : Inquiry for procurement of 4 MT Lead and 4 MT Nickel of 99.97% Purity and 99.90% purity respectively.

Offers are invited from reputed firms with atleast five years of experience in supply of Nickel, Lead and other non ferrous metals in two bid system for supply of 4 MT Lead ingots and 4 MT Nickel ingots on the following terms and conditions:

- 1) Quantity requirement : a) 04 MT of Nickel ingots with minimum purity 99.90%
(b) 04 MT of Lead ingots with minimum purity 99.97%

(c) Quantity delivered as per weighment at CWC Bonhoogly, Kolkata certified by MMTC official and MMTC's appointed surveyor shall be final.
- 2) Quality: LME Approved Brand. Certificate of Analysis issued by Producer of the material(s) or any LME approved Assayer to be submitted along with the techno-commercial bid. Please note that the techno commercial bid submitted without the Certificate of Analysis both for nickel and lead as the case may be, shall be disqualified.
- 3) Delivery place : Ex-MMTC's godown at CWC Bonhoogly, Kolkata. Unloading to be done by MMTC. Delivery to be made within 03 working days from the date of confirmation by MMTC.
- 4) Rate : Price per metric ton(PMT) to be quoted ex-MMTC's godown at CWC Bonhoogly, Kolkata as per PRICE BID which is as ANNEXURE II to this NIT.
- 5) Validity : Offer should be kept valid for 15 days from date of closing of this tender.
- 6) Payment Terms : Payment shall be made upon receipt of Invoice and after 10 days of delivery of material in our godown.
- 7) Bidder has to furnish the Performance Guarantee for Rs.1,80,000 /- (Rupees One Lac Eighty Thousand only) for due and satisfactory performance of the contract. Performance Guarantee is to be paid by way of DD/Bankers Cheque payable at Kolkata and submitted alongwith the Technical bid. Performance Guarantee shall be released only on successful and satisfactory execution of the said contract. No claim shall be admissible against MMTC in respect of interest on Performance Guarantee regardless of the time of the release. MMTC Reserves the right to forfeit the

Performance Guarantee if bidder commits any breach of contract or fails to fulfill any term (s) or condition (s) of the contract.

- 8) FORCE MAJEURE: If at any time during the currency of the contract, the performance in whole or in part by either party on any obligation under this contract shall be prevented or delayed by reason of War, Hostility, Act of Public Enemy, Civil Commotion, Sabotage, Fire, Flood, Explosion, Epidemic Quarantine restrictions, Acts of state or Act of God, hereinafter referred as eventualities, then the buyer/seller may extend the contract for the period of Force Majeure, provided notice of the happenings of any such eventualities is given, supported by a certificate of appropriate authority or chamber of commerce by either party to the other within 15 days from the date of occurrence thereof.
- 9) TERMINATION FOR DEFAULT:
- a) MMTC may, without prejudice to any other remedy for breach of purchase order/work order, by written notice of default, sent to the bidder, terminate the Agreement/work order in whole or in part.
 - b) If the bidder fails to deliver any or all of the services within the time period(s) specified in the Agreement/work order, or any extension thereof granted by MMTC.
 - c) If the bidder fails to perform any other obligation(s) under the Agreement/work order; and if the bidder, in either of the above circumstances, does not remedy his failure within a period of 7 days (or such longer period as MMTC may authorize in writing) after receipt of the default notice from MMTC.
- 10) ARBITRATION : All disputes or differences whatsoever arising between the parties out of or relating to the construction, meaning and operation or effect to the agreement or breach thereof shall be settled by Arbitration in accordance with the provisions of Arbitration and Conciliation Act 1996 and the Rules of Arbitration of Indian Council of Arbitration, award made in pursuance thereof shall be binding on both parties. The venue of the Arbitration shall be at Kolkata
