1.0 COMMODITY: Concast Mild Steel Billets; IS 2830:2012 manufactured by Neelanchal Ispat Nigam Limited (NINL), DUBURI, JAJPUR, ORISSA.

2.0 <u>DIMENSIONS, SPECIFICATIONS & QUANTITIES OFFERED:</u>

150mm x 150mm; 12 m length.

The details of the Grades of the Concast Mild Steel Billets are as given in Annexure-A.

3.0 <u>DELIVERY</u>: EX-PLANT, NINL, DUBURI, JAJPUR, ORISSA.

4.0 <u>Despatch</u>: Despatch of CC MS billets shall be done by Road only.
 However the loading of the billets shall be in NINL's scope of service.
 Buyer shall have to engage transporter for transporting of the CC MS
 Billets from NINL site.

5.0 EMD:

5.1 A fixed EMD amount as mentioned in <u>Annexure C</u> against each Lot is to be submitted for the quoted Lots alongwith the bid in the form of DD drawn in favour of MMTC Limited payable at Bhubaneswar or through RTGS as per the bank details given below, under intimation to R.O. Bhubaneswar. IFSC code of the bank branch on whom the DD is drawn or the RTGS payment details should also be mentioned under intimation to R.O. Bhubaneswar. No interest shall be payable on the EMD amount.

- 5.2 EMD submitted shall be retained by MMTC in case of successful bidder and the same would be converted into security deposit (SD). The EMD shall be released on successful completion of the tender and submission of requisite C form. In case of unsuccessful bidders the EMD will be refunded within 10 working days of finalization of the orders.
- 5.3 In case the bidder withdraws before the validity of the contract or does not execute the contract as per the terms and conditions of the tender, the EMD/SD will be forfeited.
- 5.4 EMD will not be accepted in the form of Cheques and the bids submitted with Cheques towards EMD will be rejected.
