**SCOPE OF WORK:**

To clear the cargo from vessel (break bulk – fertilizer raw material, rock phosphate) from port , movement of cargo from port and unloading the consignment at MMTC appointed custom bonded warehouse as per split BL wise. The cargo shall be moved in to bond.

**CARGO TYPE:**

BULK / BREAK BULK

**ITEM:**

ROCK PHOSPHATE

**Demurrage and Dispatch:**

Demurrage rate is USD 9,500 per day prorata and Dispatch rate USD 4750 half day on working time saved basis. Dispatch will be shared with MMTC limited at the rate if 50:50 basis.

**CARGO UNLOADING TERMS:**

Discharge rate 7500 MTS PWWD Sat noon SHEX EIU (Sat 12.00 noon – Mon 8.00 AM not to count even if sued) basis minimum 3 holds/ 3 hatches served with 3 cranes prorata if less. A hatch is only to be considered a non workable in the event of vessel crane breakdown or hatch cannot be opened due to fault of vessel. In case of breakdown of vessel's cranes, derricks, time used / lost will be deducted from lay time on prorata basis. This is as per contractual terms.

**Vessel berth Ousting Charges:**

Vessel berth ousting VBOC due to delay in handling or discharge of cargo by CHA in terms of the agreement will be to the account of CHA. The CHA however not to be responsible for ousting charges on account of priority berthing for vessels as per port priorities.
