- 1) MMTC LIMITED invite sealed quotations in two bid systems from reputed experienced and valid license holder Electrical contractors for undertaking maintenance and related work of electric installations of the office premises at MMTC, Delhi regional office , Jhandewalan, Rani Jhansi road, New Delhi. Tenderers must have completed at least three years in the field of annual maintenance of electric installation in PSU's/Banks/Govt. Departments/Govt. Institutions. Details of the services required and other terms and conditions relating to the award of Contract are given below.
- 2) **SCOPE OF WORK :** The job of electrical work shall include the following:
  - (i) The Scope of the work covers providing electrical maintenance services for all electrical systems, DB rooms, fitting and fixtures, attending electrical faults, supply and fixing of the items/works mentioned in Annexure-II at DELHI REGIONAL OFFICE, FLATTED FACTORY COMPLEX, JHANDEWALAN, New Delhi. Besides above, tenderer is required to undertake any kind of electric work which MMTC may require at any point of time in our above said premises including installation of new switches, change over switches, bus bars, MS enclosures, dismantling of old panel cable switches, new panel installation with termination , gladding of all cables etc. .
  - (ii) The tenderer shall also be fully responsible for maintenance of all equipments and electrical installations as per the instruction of MMTC.
- 3) **Validity of the contract:** The period of contract shall be for a period of two year from the date of commencement of the contract unless terminated in accordance with the provision of the agreement or in accordance with law. However, the contract may be extended for a further period of one year on written mutual consent. MMTC reserves the right to terminate the contract by giving one month notice in writing and without assigning any reason thereof.
- 4) **Eligibility conditions**
  - i) The tenderer should have a valid license for electrical work, copy of the same should be submitted.
  - ii) The tenderer shall have an experience of at least 3 years or more in this field in Govt. Departments /PSUs /reputed organization.
  - iii) Copy of GST certificate
  - iv) In case the party is registered with Ministry of MSME/ its authorized agencies, he is required to submit registration certificate and store

details in addition to above. The MSEs parties will be eligible for the benefits as applicable to them under MSMEs Act, 2006.

**5) Earnest Money Deposit (EMD) :**

- i) The tenderer shall furnish an amount of Earnest Money of Rs.10,000 (Rupees Ten Thousand only) by way of Demand Draft drawn in favour of "MMTC LTD" payable at New Delhi in physical form for both type i.e. physical bid submission type or e-tenderer bid type . - 7) The Tender should remain valid for a period of 90 days from the date of opening of PRICE BID.
- 8) Overwriting in the rates quoted will render the tender to be summarily rejected.
- 9) **The rates should be inclusive of all charges without GST. The GST percentage should be separately mentioned.**
- 10) Agencies are advised to visit the place of work to acquaint themselves with requirement and quantum of work realistically before quoting the rates. No claim shall be entertained later on the

## TERMS & CONDITIONS

- 1) No increase in the rate shall be given during the contract period.
- 2) Services of two electricians of the tenderer shall have to be available in office premise from 9:00 Hrs to 20:00 Hrs. for attending day to day electrical complaints on all working days and Saturdays. No separate wages will be paid for electricians. The charges for providing electricians are deemed to be included in item No.11 of Price Bid). However, extra charges will be paid for deputing the electrician to attend the work of in emergency at our work place after above hours and out of the office premises per visit/per day as the case may be at the rate quoted by L1 party.
- 3) The work is to be done on item rate basis. The rates should include the cost of the items, labour charges, transportation of material to and fro from the site as and when required. Nothing extra is payable on this account. Transportation of any wastage, exchange of rejected /defective / surplus material etc. shall have to be arranged by the tenderer at his own risk and costs. Also any material brought inside or taken out of the premises shall have necessary prior permission to do so. The amount of EMD of Rs. 10,000/- deposited at the time of participation will be converted into interest free security deposit which will be discharged after completion of tenderer performance obligations.
- 4) The tenderer shall also ensure that no labour below the age of 18 years is employed by him for the above mentioned jobs.
- 5) The tenderer shall ensure that workmen deployed by him should be competent and qualified to carry out electrical works ,should behave decently and do not indulge themselves in any such activities which are unbecoming on the part of a person working in a Government Office.
- 6) The tenderer shall have to make his own arrangements for storage of material required for the job.
- 7) The tenderer shall be responsible for the safety of all items of furniture, office equipment and other fittings provided in the premises and shall be liable to make good of any loss to the same if damaged during the execution of work which shall be recoverable from his monthly bill or the security deposit or any other dues payable to the tenderer by the company.
- 8) The tenderer shall be responsible for any injury/death caused to persons, which may arise from the operations or neglect of any person of the tenderer team or any person engaged by him for any purpose related to the execution of this contract or to things (fittings/fixtures/furnishings etc.) any damage caused to any property of MMTC etc. The tenderer/contractor shall
