SUB: e-Tender for Electrical Maintenance Service work in MMTC Office, CO.

MMTC LIMITED invites open e-tender in two bid systems from reputed experienced and valid licensed holder Electrical contractors for undertaking maintenance of electric installations of the office premises in MMTC in New Delhi. Bidders must have completed at least three years in the field of annual maintenance of electric installation in PSU's/Banks/Govt. Departments/Govt. Institutions. Details of the services required to be provided and other terms and conditions relating to the award of contract are given below:-

- 1) SCOPE OF WORK: The job of electrical work shall include the following:
 - i) Scope of the work covers providing electrical maintenance services for all electrical systems, DB rooms, fitting and fixtures, attending electrical faults, supply and fixing of the items/work mentioned in Annexure–II at SCOPE complex, Lodhi Road, New Delhi. Besides above, Successful Bidder is required to undertake any kind of electric work which we may require at any point of time in our above said premises.
 - ii) The agency shall also be fully responsible for maintenance of all equipments and electrical installations as per the instruction of MMTC.
- 2) Validity of the Contract: The period of contract shall initially be for a period of two years from the date of issue of work order commencement. However, the contract may be extended for a further upto another one year with mutual consent on same rates & terms.
- 3) Under Public Procurement Policy (PPP) issued by Ministry of Micro, small & Medium Enterprises, Government of India for Micro & Small Enterprises (MSEs), a minimum 25% share out of the total procurement of goods and services by Central Ministries/ Departments/Public Sector Undertakings are to be made from MSEs. Further out of 25% target of annual procurement from MSEs, a sub-target of 5% is earmarked for procurement from MSEs owned by Scheduled Cast (SC)/Scheduled Tribes (ST) entrepreneurs and an additional 3% reservation for the Women owned MSEs within the above 25% reservation. Preference will be given to MSEs as per guidelines prescribed under MSMEs Act, 2006.
- 4) Under Procurement Policy for Micro & Small Enterprises (MSEs) order 2012" as notified by the Government of India, Ministry of Micro Small & Medium Enterprises, New Delhi vide Gazetta Notification dated 23/03/2012, the parties registered with MSEs or its authorised agencies such as NSIC etc., are exempted from depositing the participation fee and EMD.
- 5) Eligibility conditions & documents requirement :

- i) The bidder shall have an experience of previous 3 years consecutively or more in this field with PSU/Govt. Office/MNCs. In this regard copies of performance certificate/completion certificate/work order should be attached, from the companies on their letter head.
- ii) Copy of valid GST and PAN card should be submitted.
- iii) Copy of valid license for electrical work issued from the concerned agency.
- iv) Information in Annexure I.
- v) The bidder should not have been blacklisted by any Department/Ministry / Government of India/Semi Government/ PSUs etc. (Declaration to be submitted).
- vi) In case the party is registered with Ministry of MSME/its authorized agencies, the bidder is required to submit registration certificate and store details in addition to above. The MSEs parties will be eligible for the benefits as applicable to them under MSMEs Act, 2006.
- vii) Earnest money deposit (EMD): The bidder shall furnish an amount of Earnest Money of Rs. 20,000/- (Rs. Twenty thousand only) through online mode (RTGS/NEFT).

Submission of Tenders & other terms:

- 6) All interested service providers are requested to submit TECHNICAL BID (Annexure I) alongwith proof of depositing EMD and Financial bid (Annexure II) online only and bid submission other than E-mode will not be considered.
- 7) The rates quoted in the Financial Bids should be both in words and figures in prescribed format (Annexure- II) only.
- 8) Tender Document is available on the website of the MMTC LIMITED i.e. www.mmtclimited.com and nttp://eprocure.gov.in. and abcprocure.com The intending bidders may download the tender document containing the terms & conditions and submit the same in the prescribed formats by 03/03/2021 at 3.00 p.m.
- 9) Bids received late due to any reason, whatsoever, shall be rejected outright.
- 10) Each & every page of the tender documents should be signed & stamped by the bidder at the bottom as acceptance of all terms & conditions of tender before submitting in E-Mode.
- 11) Technical bids shall be opened on 04/03/2021 at 1130 hrs in the presence of authorized representatives of bidders who wish to be present.
- 12) The Technical Bids shall be scrutinized/verified by MMTC in terms of the tender and subsequently the eligible PRICE BIDS shall be opened within a period of 45 days. The bidder who has quoted lowest grand total of terms in Annexure II shall be selected L-1 bidder.
- 13) Bidders are advised to visit the place of work for ascertaining the nature and volume of work realistically before quoting the rates. MMTC does not guarantee the execution of all items / service as mentioned in Price Bid since the same is dependent on requirements from time to time.

- 14) The rate should be mentioned in figures as well as in words inclusive of all charges. In case of any difference between figures & words the amount mentioned in words shall be treated as final. Applicable GST shall be extra.
- Earnest money deposit (EMD): The bidder shall furnish an amount of Earnest Money of Rs. 20,000/- (Rs. Twenty thousand only) through online mode (RTGS/NEFT) in MMTC Limited account maintained with HDFC Bank Ltd., 209 214, KAILASH BUILDING, 26, KASTURBA GANDHI MARG, NEW DELHI-110001 having Account No. 00030110000359, IFSC HDFC0000003. The EMD of the unsuccessful bidder shall be returned without any interest subsequent to the award of contract to the successful bidder.
- 16) No request for transfer any previous deposit of EMD or Security Deposit or payment of any pending bill held by the MMTC in respect of any previous supply will be entertained. No claim lie against the MMTC in respect of erosion in the value or interest on the amount of EMD or Security Deposit. The tender without EMD will be summarily rejected (except MSME parties).
- 17) The Earnest money may be forfeited in the event of :
 - i) If a bidder withdraws its bid during the period of its validity.
 - ii) In the case of successful bidder, if the bidder fails to commence the work as required.
- 17) Performance Security:
 - i) The successful bidder (including MSME) shall be required to deposit an amount of Rs. 20,000/- (twenty thousand only) as Performance Security within 10 days of issue of letter of offer (LOI) for due and satisfactory performance of the agreement.
 - ii) Performance Security shall be submitted through online mode (NEFT/RTGS) which shall be interest free. The EMD can be converted to Security Deposit for L-1 Party.
 - iii) No claim shall be admissible against MMTC in respect of interest on Performance Security regardless of the time of release. On expiry of agreement, such portion of the said performance guarantee, as the case may be, appropriated for any losses / damages incurred to MMTC.
 - iv) Performance security shall be released to successful bidder on successful and satisfactory execution of work/agreement.
 - v) If the successful bidder fails or neglects any of his obligations under the tender/agreement, MMTC reserves the right to forfeit either whole or any part of Performance Security furnished by the bidder towards penalty for such failure.
- 18) Payment: Payment to the successful bidder shall be released on successful completion of work on monthly basis on submission of GST complied bill for the services rendered in the particular month through E-payment system.
- 19) The successful bidder shall be determined on the basis of lowest consolidated rates/ quotes and has to enter into a separate agreement.
- 20) Any modification of contract / agreement shall be in writing and signed by an authorised representative of each party which shall form a part of existing contract/agreement.
- Validity of Tender: Rates quoted by the firm shall remain valid for a period of 90 (Ninety) days.

- The work is to be done on item rate basis. The rates should include the cost of the items, levies/custom duties/surcharges, labour charges, transportation of material to and fro, from the site as and when required. Nothing extra is payable on this account except GST as applicable. Transportation of any wastage, exchange rejected/defective /surplus material etc. shall have to be arranged by the successful bidder at his own risk and costs. Also any material brought inside or taken out of the premises shall have necessary prior permission to do so.
- 23) No increase in the rate shall be given during the tender/agreement/contract period.
- TDS and any other Government levies and taxes applicable from time to time shall be deducted from the bill amount. Bills should be submitted in triplicate showing proper split of taxes/charges. GST provision compliance should be done without any additional liability on MMTC and for which successful bidder shall keep MMTC indemnified from such liability claim etc.
- Services of two electricians of the Successful Bidder shall have to be available in office premise from 900 Hrs to 2100 Hrs.(duty of electrician 9 am to 5 pm and 1.00 pm to 9.00pm) for attending day to day electrical complaints on all working days and Saturdays. No separate wages will be paid for electricians. The charges for providing electricians are deemed to be included in item No.15 of Price Bid). However, extra charges will be paid for deputing the electrician to attend the work in emergency at our work place after above hours and out of the office premises per visit/per day as the case may be at the rate quoted by L1 party.
- The Successful Bidder shall also ensure that no labour below the age of 18 years is employed by him for the above mentioned jobs and minimum wages including all statutory payments must be paid to the Electrician deputed in the office premises for executed the work as per Govt. Guidelines. A certificate/transfer of wages to the electrician must be submitted with the monthly bill.
- 27) The Successful Bidder shall ensure that workmen deployed by him behave decently and do not indulge themselves in any such activities which are unbecoming on the part of a person working in a Government Office. The Successful Bidder shall have to make his own arrangements for storage of material for the job.
- The successful bidder shall be responsible for any injury caused to persons or things (fitting/fixtures/furnishings etc.) any damage caused to any property of MMTC etc. which may arise from the operations or neglect of any person of the Successful Bidder team or any person engaged by him for any purpose related to the execution of this contract/tender. The tenderer/Successful Bidder shall indemnify MMTC of all liabilities arising out of his operations in any way under any acts of the Government and also in award of any compensation or damages consequent upon any claim arising out of the above.
- 29) INDEMNITY CLAUSE: The successful bidder undertakes to fully indemnify and at all times keep MMTC fully indemnified and harmless against any actions, sanctions, claims, losses, demurrage, demands, expenses or costs whatsoever that MMTC may incur and / or suffer on account of any default on the part of the successful bidder in the discharge of the obligation under this agreement, including but not limited to the claims on account of

any other circumstances incidental to the scope of work. In case, successful bidder fails / has failed to give the services as agreed in the tender, scope of work, terms and condition, subsequent agreement, undertaking or if MMTC at its sole discretion considers that the successful bidder is not in a position to fulfill its obligations, MMTC may without being obliged to do so and without prejudice to any of its other rights and remedies, repudiate this agreement and procure the scope of work done at the cost and risk of the successful bidder from alternative sources. The provisions of the aforementioned indemnity clause shall survive the termination of this agreement.

Nothing in the Agreement constitutes any fiduciary relationship between the MMTC and Selected Bidder/ Bidder's Team or any relationship of employer employee, principal and agent, or partnership, between the MMTC and Selected Bidder.

No Party has any authority to bind the other Party in any manner whatsoever except as agreed under the terms of the Agreement. MMTC will not be under any obligation to the Implementation of successful bidder except as agreed under the terms of the Tender/subsequent Agreement.

- 31) All safety precautions should be taken during execution of the work and MMTC will not be responsible for any accident caused to labour engaged by the successful bidder during execution of work.
- 32) It is expressly understood and agreed to between the parties to this tender that the persons deployed by the successful bidder for the above work shall be the employee of the successful bidder for all intents and purposes and in no case there shall accrue any relationship of employers & employee between the said person(s) & MMTC implicity and or explicity.
- 33) The successful bidder/contractor shall not sub-contract, transfer, assign or otherwise part with the tender / agreement or any part thereof, either directly or indirectly or transfer any interest, right, benefit or obligation under the agreement.

- 35) MMTC reserves the right to cancel the Contract/subsequent agreement any time during the currency of the contract without assigning any reason, whatsoever, if the services provided by the firm are found to be unsatisfactory.
- ARBITRATION CLAUSE: Any dispute or difference whatsoever arising between he parties relating to construction, interpretation, application, meaning, scope, operation or effect of this contract or the validity or the breach thereof, shall be settled by arbitration in accordance with the Rules of Arbitration of the "SCOPE" and the award made in pursuance thereof shall be final and binding on the parties. The venue and seat of Arbitration shall be New Delhi.
- 37) If at any time during the existence of this agreement either party is unable to perform in whole or in part any obligations under this agreement because of war, hostility, military operations, civil commotion, sabotage, quarantine, restrictions, acts of God and acts of Government (including but not restricted to prohibitions of exports and imports), fires, floods, explosions, epidemics, strikes, or any other labour trouble, embargoes, then the

date of fulfillment of any obligations engagement shall be postponed during the time when such circumstances are operative.

If operation of such circumstances exceeds **three months**, either party shall have the right to refuse further performance of the agreement in which case neither party shall have the right to claim eventual damages. The party which is unable to fulfill its obligations under the present agreement shall, within 15 days of occurrence of any of the causes mentioned in this clause inform the other party of the existence or termination of the circumstances preventing the performance of the agreement. In case either party invocating the force majeure clause, it is incumbent on him to submit the documentary evidence to that effect from the competent government authority/chamber of commerce. Notwithstanding this, provisions relating to indemnity, confidentiality survive termination of the agreement.

- 38) Compliance with Law: The Selected Bidder shall comply with the laws in force in India in the course of performing the Agreement/contract.
- During the performance of the work, the successful bidder shall at his own cost and initiative fully comply with all applicable laws of the land and with all applicable by-laws, labour laws, rules, regulations and any other provisions having the force of law, made or promulgated or deemed to be made or promulgated by any Government, Government agency, or Department, Municipal board, Government or other regulatory or authorized body of persons and shall provide all certificates of compliance therewith as may be required by such applicable law, by-laws, labour laws and rules, regulations, orders. The successful bidder shall assume full responsibility for the payment of all contributions and payroll taxes, as to its workforce, servants or agents engaged in the performance of the work specified in the tender/agreement documents.

If during the tenure of work stipulated herein, successful bidder may found violating any laws, norms attributed & applicable from this tender/subsequent agreement, in such event, the successful bidder will be solely liable to face the consequence of violation, inasmuch, the successful bidder may keep MMTC safe and indemnify from any of the losses/risk which may occasioned by non-performing any statutory rules, regulation or law in force.

- 40) Governing Law: The tender / agreement / contract shall be governed in accordance with the Laws of India.
- 41) Holiday Listing Clause: Notwithstanding anything contained in the agreement, MMTC's policy for Holiday-Listing of an Agency mutatis mutandis applies to this agreement and in the event, the agency(s) while discharging its obligations under the Agreement or otherwise, come(s) within the ambit of the said policy, MMTC at its sole discretion reserves the right to suspend/discontinue dealings or take any curative measures with the agency(s) in accordance with the policy in force.
- 42) CONFIDENTIALITY AND SAFEGUARD OF PROPERTY: MMTC and Sucessful bidder respectively agree to keep in confidence, and not to disclose or use for its own respective benefit or for the benefit of any third party (except as may be required for the performance of services under this agreement or as may be required by law), any information, documents, or materials that are reasonably considered confidential regarding each other's products, business, customers, MMTCs, suppliers, or methods of operation; provided, however, that such obligation of confidentiality will not extend to anything in the public domain or that was in the possession of either party prior to disclosure. MMTC and

Successful bidder will take reasonable precautions to safeguard property of the other entrusted to it.

43) FRAUD PREVENTION POLICY: All the bidders shall be required to certify that they would adhere to the Fraud Prevention Policy of MMTC and shall not indulge themselves or allow other (working in MMTC) to indulge in fraudulent activities and that they would immediately apprise the organization of the fraud/suspected fraud as soon as it comes to their notice. Concealment of facts regarding their involvement in fraudulent activities in connection with the business transaction(s) of MMTC is liable to be treated as crime and dealt with by the procedures of MMTC as applicable from time to time.

44) General:

Entire Agreement: The terms and conditions laid down in this Tender, scope of work, subsequent agreement and all annexures thereto as also the Proposal and any Attachments/annexes thereto shall be read in consonance with and form an integral part of the Agreement.

The subsequent Agreement/contract constitutes the whole of the agreement between the Parties relating to the matters dealt with herein along with any allied exchange correspondence and, save to the extent otherwise provided herein, no undertaking, representation, term or condition relating to the subject matter of subequent Agreement/contract not incorporated in this Agreement/contract shall not be binding on either of the Parties.

All provisions and the various clauses of subsequent Agreement/contract are, notwithstanding the manner in which they have been grouped together or linked grammatically, severable from each other. Any provision or clause of subsequent Agreement/contract which is or becomes unenforceable in any jurisdiction, whether due to voidness, invalidity, illegality, unlawfulness or for any other reason whatever, shall, in such jurisdiction only and only to the extent that it is so unenforceable, be treated as pro non scripto and the remaining provisions and clauses of subsequent Agreement shall remain of full force and effect. The Parties declare that it is their intention that Agreement would be executed without such unenforceable provision if they were aware of such unenforceability at the time of execution hereof.

45) MMTC do not bind to accept the lowest Tender and reserves the right to accept or reject any tender or give work order to one or more party(ies) at its sole discretion without assigning any reason whatsoever.
