

CORRIGENDUM NO. 1 DTD. 17/07/2019

E-NIT FOR ANNUAL MAINTENANCE CONTRACT FOR OPERATION AND MAINTENANCE OF ELECTRICAL INSTALLATION AT MMTC HOUSE, BKC, BANDRA (EAST) MUMBAI - 400 051.

Tender No. MMTC/Mum/Admn(EM)/ 2019-20/02 dated 08/07/2019

1. The Clause (a) of Yearly Maintenance under Scope of Work is being amended as below:

Contractor has to arrange for testing of HT/ LT Breakers and all relays from approved/reputed agencies and should submit the relative certificates to MMTC every year or as directed. The testing charges shall be within the scope of the maintenance charges.

2. The Clause C (5) pertaining to shift timings is being amended as follows:

It is essential that one technical person must be made available at site 24 x 7 on all days (including holidays) as per timings mentioned below:

First Shift: 0700 hrs to 1500 hrs
Second Shift: 1500 hrs to 2300 hrs
Third Shift: 2300 hrs to 0700 hrs

The timings of deployment may be changed anytime, which are to be followed and no extra payment will be made on this account.

Accordingly the Clause 26 in the agreement also stands amended.

3. The following clause (no. 64) in the Agreement is being modified in the above tender as below:

LIQUIDATED DAMAGES: The contractor shall perform his duties and responsibilities as per the scope of the work as per Appendix - A of the tender documents. If the contractor fails to perform any or all the duties and responsibilities and MMTC has to get the work done through other agency/contractor so as to operate the plant, MMTC shall recover liquidated damages from the contractor to the extent of 10% of the annual contract value. The quantum of liquidated damages assessed and levied by MMTC Limited shall be final and binding on the Contractor.

4. The Clause 42 (c) under WAGES TO WORKMEN/LABOUR in General Terms and Conditions is being amended as follows:

The contractor shall ensure payment of minimum wages to all the eligible workers as per the minimum wage rate issued by State Govt. /Central Govt. whichever are higher from time to time.
Minimum wages should be as per Central/ State Gov. rates, whichever are higher.

5. The due date of tender submission, tender opening of technical bid, pre-inspection etc. will be as given at Page no. 2 of the tender
