MMTC invites sealed tenders from interested domestic buyers for sale of 5267 MT of IS 2830 Concast Mild Steel Billets manufactured by NINL. The bids have to be submitted till 17.12.2013 by 15:00 hrs.

#### <u>Terms and Conditions of the tender</u>

**1.0 COMMODITY:** Concast Mild Steel Billets; IS 2830 manufactured by Neelanchal Ispat Nigam Limited (NINL), DUBURI, JAJPUR, ORISSA.

#### 2.0 <u>DIMENSIONS, SPECIFICATIONS & QUANTITIES OFFERED:</u>

150mm x 150mm; 12 m length.

The details of the Grades of the Concast Mild Steel Billets along with the respective quantities are as given in Annexure-A. The gradewise chemical composition of the quantities mentioned at Annexure-A is detailed at Annexure-B.

- 3.0 **DELIVERY**: EX-PLANT, NINL, DUBURI, JAJPUR, ORISSA.
- 4.0 <u>Despatch</u>: Despatch of CC MS billets shall be done by Road only. However the loading of the billets shall be in NINL's scope of service. Buyer shall have to engage transporter for transporting of the CC MS Billets from NINL site.

#### 5.0 SUBMISSION OF BIDS:

**5.1** Bids shall be submitted in sealed covers in two parts as mentioned below.

#### PART A: Technical Bid

Technical Bid should comprise of:

- 1. Duly filled Technical bid as per format given at **Annexure C**.
- 2. Tender signed on all pages as proof of acceptance of all terms and conditions.
- 3. EMD by DD or RTGS details.

The signed tender and the EMD should be put together in an envelope superscribing "TECHNICAL BID FOR TENDER NO.: MMTC/STEEL/BILLETS/TENDER/2013-14/02 DATED: 27.11.2013".

#### PART B: Price Bid

Lotwise prices are to be quoted in the price bid as per the format given at **Annexure D**. Bidder has to bid for minimum one complete Lot. Part quoting for the Lots will not be permitted.
