MMTC invites sealed bids from interested domestic buyers for sale of 11000 MT +/- 5% of Concast Mild Steel Billets at Seller's option, on 'AS IS WHERE IS AND NO COMPLAINT BASIS'. The billets would be available on Ex- plant NINL basis. The bids have to be submitted till 26.12.2013 by 15:00 hrs.

#### TERMS AND CONDITIONS OF THE TENDER

**1.0 COMMODITY:** Concast Mild Steel Billets; manufactured by Neelanchal Ispat Nigam Limited (NINL), DUBURI, JAJPUR, ORISSA.

#### 2.0 <u>DIMENSIONS, SPECIFICATIONS & QUANTITIES OFFERED:</u>

150mm x 150mm x 9-12 m length.

(Billets could also be cut into 6m length at buyer's cost.)

The details of the Lotwise Concast Mild Steel Billets along with the respective quantities are as enumerated in Annexure-A.

- 3.0 **DELIVERY:** EX-PLANT, NINL, DUBURI, JAJPUR, ORISSA.
- 4.0 <u>Despatch</u>: Despatch of CC MS billets shall be done by Road only. However, the loading of the billets shall be in NINL's scope of service. Buyer shall have to engage transporter for transporting of the CC MS Billets from NINL site.

#### 5.0 SUBMISSION OF BIDS:

**5.1** Bids shall be submitted in sealed covers in two parts as mentioned below.

#### **PART A: Technical Bid**

Technical Bid should comprise of:

- 1. Duly filled Technical bid as per format given at **Annexure B**.
- 2. Tender signed on all pages as proof of acceptance of all terms and conditions.
- 3. EMD by DD or RTGS details.

The signed tender and the EMD should be put together in an envelope superscribing "TECHNICAL BID FOR TENDER NO.: MMTC/STEEL/BILLETS/TENDER/2013-14/03 DATED: 5.12.2013".

#### PART B: Price Bid

Lotwise prices are to be quoted in the price bid as per the format given at **Annexure C**. Bidder has to bid for minimum one complete Lot. Part quoting for the Lots will not be permitted. The Price bid should be put in an envelope super scribing "PRICE BID FOR TENDER NO.: MMTC/STEEL/BILLETS/TENDER/2013-14/03 DATED: 5.12.2013".

Both the above envelopes, one containing the **Technical Bid** and the other containing the **Price Bid** should be put in another envelope superscribing "TENDER NO. <u>MMTC/STEEL/BILLETS/TENDER/2013-14/03</u> DATED: 5.12.2013 FOR CONCAST MILD STEEL BILLETS ON EX-PLANT NINL BASIS".

- 5.3 Bidders shall quote the rates in figures as well as in words. Corrections if any should be initialed. In case of any discrepancy in words and figures, the rate quoted in words will be treated as final.
- In case of discrepancy in the value with reference to the unit rate & the quantity vis-à-vis the total amount column, the unit rate quoted will be taken as final.

5.5 The tender documents must be duly signed on all the pages as a token of

acceptance of all the terms and conditions.

5.6 Bids received through fax/e-mail or bids received after the due date or

time will be rejected.

6.0 EMD:

6.1 A fixed EMD amount as mentioned in **Annexure C** against each Lot is to

be submitted for the quoted Lots alongwith the bid in the form of DD

drawn in favour of MMTC Limited payable at Bhubaneswar or through

drawn or the RTGS payment details should also be mentioned under

6.3 In case the bidder withdraws before the validity of the contract or does

not execute the contract as per the terms and conditions of the tender,
