Terms and Conditions of the EOI

1. Introduction:

MMTC Limited is a Govt. of India Enterprise, having its Corporate Office at Core-1, Scope Complex, Lodhi Road, New Delhi-110 003 (hereinafter called MMTC). MMTC Limited was set up in 1963 under the Ministry of Commerce, Government of India. The company is engaged in international and domestic trading of commodities, which include Minerals, Precious metals, Non-Ferrous metals, Steel, Power, Fertilizer & Fertilizer raw materials, Coal & Hydrocarbon, Agro commodities, Drugs, Pharmaceuticals & Chemicals and General trade.

MMTC has a strong nation-wide presence with offices covering all the major consumption centers and port towns in India with deployment of over 1,300 highly skilled and experienced manpower across the country. With the 'state of art' wide area network providing on-line information exchange throughout the country through ERP, the company has capability to pro-actively source items surplus to domestic demand for exports from India and also to co-ordinate the demand of domestic users for import.

MMTC invites "Expression of Interest (EOI)" from Indian Manufacturers with past experience and CGMP certificate (WHOGMP-COPP) for manufacturing & supply of formulation as per the attached list. MMTC is interested to shortlist reputed suppliers who

are willing to supply at a competitive price on regular basis at domestic depots for sale in domestic market preferably to actual users.

MMTC reserves the right to invite tenders for manufacture and supply of Formulations from the empanelled manufacturer.

2. Material Quality:

MMTC require quality material, conforming to international specification. Customers of MMTC include institutional buyers, who have stringent quality norms for accepting raw materials. Quality certificate from producer/assayer nominated by MMTC is essentially a prerequisite for MMTC's purchase contract.

The details of formulations are under following categories:

- a) Tablet
- b) Capsule
- c) Injections
- d) Liquids
- e) External preparations
- f) Eye/Ear Drop

3. Pre- Qualification criteria for selection as a prospective Supplier:

The supplier has to submit the following documents/ details /accept terms and conditions in order to be considered for the empanelment process:

- a) Brief details/Corporate Profile of the company.
- b) The Indian Manufacturer supplier should have minimum two years of supplying/ manufacturing experience in those formulations for which the application is being made.
- c) The manufacturer should possess valid GMP Certificate.
- d) The supplier shall clearly mention monthly supply capacity of formulation for which the application is being made.
- e) Latest Annual Report of the company for past two financial years.
- f) Profit earned at least two out of last three years.
- g) A turnover of INR 2 Crores/year in any of the last two years with satisfactory bank reference.

- h) Should accept to abide by all terms and conditions for manufacturer of formulation as laid down by Govt. of India from time to time.
- i) Copy of Certificate of Incorporation duly self-attested.
- j) Board Resolution/ letter from partners authorizing all or any one of the Directors/Partners to sign the documents.
- k) Affidavit to the effect that the supplier has not been blacklisted by Indian Govt. Agencies/State Agencies/ MMTC as on date.
- Should accept responsibility for all quality / therapeutic claims of the material and indemnify MMTC on this account. Shall submit an indemnity bond along with detailed claim procedure on this account which would be binding for settlement of claims.
- m) Registration with appropriate authority.
- n) Central / State government undertakings, companies, PSUs etc. shall be considered for empanelment and supplies even if these Govt. / PSU units do no fulfill all the required criteria, these being Govt./ PSU units.

4. Scope of work:

- a) The selected applicant/s will form part of MMTC's panel which will act as backup suppliers for MMTC Limited. MMTC expects to regularly execute contracts of supply with its panel of suppliers on CIF/C&F/CFR/FOB basis for designated depot (Indian).
- b) The prices and commercial terms will be decided subsequently with the empanelled suppliers.
- c) The selected supplier(s) shall ensure compliance of all the Government regulations/ conventions/ policies/ guidelines/ orders etc., in force related to any or all of the above activities.
- d) Supplier shall undertake to abide by the statutory requirements of the Indian Government from time to time.

5. Submission of Expression of Interest:

a) The EoI document can be downloaded free of cost from our website www.mmtclimited.gov.in or the central government e-procurement portal www.eprocure.gov.in. The same can also be obtained from General Manager

- b) Those suppliers who are interested to be empanelled with MMTC and meet the specified criteria may apply with full details, indicating
 - i. Name and designation of authorized official to deal with.
 - ii. Details about Applicants Banker like complete address and contact details.
 - iii. Certificate from their leading Bankers indicating period of their association with the company, name and designation of the authorized signatories of the company, registered address and present status of the company.
 - iv. Certificate from State Drug Controlling Authority to the effect that the firm is not convicted under Drugs and Cosmetics Act 1940
- c) The EoI has to be submitted by post / email / drop in the box kept at MMTC Limited, Corporate office, 5th Floor, Drugs, Pharmaceuticals & Chemicals Division, Core 1, Scope Complex, 7, Institutional Area, Lodhi Road, New Delhi- 110 003.
- d) The applications have to be submitted before **1630 Hrs on 06.01.2017.**
- e) Applications received after the due date and time due to any postal delay will not be considered.
- f) Applications sent through Fax and email be followed up by post confirmation copy.
- g) Applications misstating the facts will be summarily rejected. Applications incomplete in any form may be asked to supplement and update the information, and on this MMTC reserves the full rights of consideration or rejection.
- h) The EoI documents must be duly signed on all the pages as a token of acceptance of all the terms and conditions.

6. General Terms and Conditions:

- a) It may be noted that this EOI is only for manufacture & supply of Pharmaceutical formulation in India.
- b) MMTC reserves the right to accept or reject any/all offer of Expression of Interest without assigning any reason whatsoever.
- c) Final selection of Suppliers, for each of the stated items from the EoIs received will be done at the discretion of MMTC and the decision of MMTC will be final and binding on all participants.

- d) Empanelment of suppliers by MMTC does not entail any commitment from MMTC for contracts during the validity of empanelment.
- e) MMTC reserves the right to abandon any part or whole of the process without giving prior notice to prospective applicants.
- f) The terms mentioned in this EoI are only illustrative and not exhaustive. The chosen supplier will be required to enter into contract as devised by MMTC to fully protect MMTC's interest and also the interest of prospective customers.
- g) MMTC is not bound contractually or in any other way to any prospective supplier to this EoI. MMTC is also not liable for any cost or compensation incurred by the bidders to this EoI.
- h) Validity of empanelment under this EoI shall be for duration of one year from the date of acceptance by MMTC, which may be renewed on basis of performance of the party, at the sole discretion of MMTC. Validity of EoI can also be terminated by MMTC at its sole discretion.
- i) Ownership of EoI documents and information therein (all EoI documents) shall be property of MMTC on submission.
