### <u>CIRCULAR INVITING EXPRESSION OF INTEREST FROM</u> <u>POULTRY/CATTLE INDUSTRY FOR PURCHASE OF IMPORTED MAIZE</u> (FEED GRADE) UNDER TRQ SCHEME

Sub: Procedure/terms & conditions for import of various items under Tariff Rate Quota (TRQ) - Maize (Corn).

MMTC intends to import feed-grade Maize (Corn) for the poultry/cattle industry.

The Applicants desirous of getting imported feed-grade Maize (Corn) under TRQ may register with MMTC by 13<sup>th</sup> Aug 2019 and submit the following documents along with application form on its letter head for allocation of quota:-

1. Consent of the applicant authorizing MMTC to apply on their behalf indicating the specific quantity for allocation of the quota for import of Maize and indicating the port where they would like to take delivery of the material. Further, to pay application fee @ Rs 18.50 per MT (inclusive of GST) for the applied quantity through DD/ Banker's in favour of "MMTC Limited". In case of non/ less allotment, excess fee would be returned without interest and GST.

- 3. A copy of registration certificate confirming its Registration with the Registrar of Companies, if available.
- 4. A copy of registration certificate(s) with the sales tax/VAT/GST.
- 5. A copy of the PAN/TAN No. Certificate.
- 6. A copy of registration certificate from the concerned State Government/ Association of Poultry etc to establish applicant as actual end user.
- 7. A copy of valid certificate of importer-exporter code, if available.
- 8. A self certification in application form indicating the quantity of maize purchased and consumed by the actual end user in the last three financial years.

- 9. The applicant to submit Self declaration on non judicial stamp paper of Rs.100/that applicants who had been allocated quota for imported maize during the preceding years have not defaulted in the matter of compliance of actual user condition or is not under scrutiny by any of the statutory authorities including DRI, Customs or Income Tax, etc. If yes, the details of such violation be provided on a separate annexure along with the application.
- 10. Imports would be organised at mutually agreed price and material would be sold after receiving 100% payment (25% advance at the time of finalisation of trade) including the incidentals like LC charges, trading margin of MMTC, statutory levies, custom duties, etc and security deposit. A separate consent letter confirming to agree to pay Trade Margin to MMTC as mutually agreed.
- 11. Applicant to execute an unconditional and unequivocal undertaking on requisite non-judicial stamp paper of appropriate value duly notarized that the maize imported through MMTC under TRQ scheme shall be consumed in their farm/unit located at given address and will not be traded.

# The applicants who have already submitted their documents with MMTC need not submit again.

The applicant would also be required to abide by the MMTC's terms, conditions and procedures of import of Maize under TRQ and also to sign an Associateship Agreement with MMTC.

MMTC reserves the exclusive right to accept or reject either partially or wholly the application filed by the applicant without assigning any reason whatsoever.

Applicants, who wish to import and clear their quota through Delhi/Chennai/Mumbai/Bengaluru/Vizag/Kolkata/Hyderabad/Bhubanswar, are requested to submit their application with the respective offices.
