Invitation for Expression of Interest for Empanelment of Associate Manufacturer for supply of aluminum conductors, power transformers, cables for supply to various Projects located in India and overseas through MMTC.

MMTC invites Expression of Interest for empanelment of manufacturers of aluminum conductors, power transformers, cables for supply to various projects located in India and overseas.

MMTC is a Government of India Enterprise under the administrative control of Department of Commerce. For participation in various tenders for supply of engineering products listed above, MMTC intends to create a panel of reputed manufacturers.

1. Pre qualification criteria:

Interested prospective Associate/s who are manufacturers, have to submit the following documents/details in order to be considered for the empanelment process:

- i) Brief details of the company including products manufactured and installed capacity. Annex I
- ii) The prospective Associate Manufacturer should have minimum 3 years' experience in the commodity (Aluminum conductors, cables, transformers) for which the application is being made. Accumulated minimum supply of orders (Domestic and Exports) valuing Rs. 100 crores is required to be fulfilled by the Applicant in the last 3 years. Preference shall be given to applicants with experience in Exports in respect of Export enquiries / Export Tenders received by PEC.
- iii) Annual report of the company for the past 3 years.
- iv) Supplier to submit D&B report or equivalent create rating report minimum Satisfactory or Fair Rating which is dated not earlier than 1.11.2017
- v) Company Catalogue, Product literature and Brochures. ISO certification

- vi) Copy of documents like certificate of incorporation, Memorandum of Association, copy of the license , IT Returns / GST Registration etc. duly self attested.
- vii) Bank certificate from Scheduled Bank on credit worthiness and dealings.
- viii) Board resolution/letter from the partners authorizing all or any of the Directors/partner to sign the documents.
- ix) Affidavit to the effect that the bidder has not been black listed by any State or Central Government agencies or PSU/ MMTC or Foreign Buyers as on date.

2. Scope of work:

- i) The selected applicants will form part of MMTC's panel who will act as Associate Manufacturer / Supplier for MMTC Limited.
- ii) MMTC would be participating in the various overseas tenders as well as domestic tenders for supply of engineering products (Aluminum conductors, cables, transformers etc.).
- iii) Prior to submission the offer to the Project Authority inviting tender, MMTC will decide on the back up supplier amongst the panel created.
- iv) The selected Associate shall ensure compliance of the tender condition.
- v) The Associate shall also undertake to abide by the statutory requirement of the Indian Government from time to time.

3. Submission of Expression of Interest:

- i) The EOI document can be downloaded from the MMTC's website www.mmtclimited.com or the Central Government E Procurement portal www.eprocure.gov.in , <https://mmtc.abcprocure.com>.
- ii) The EOI has to be submitted in the tender box kept at 3rd floor, MMTC Limited, Core-1, SCOPE Complex, 7, Institutional Area, Lodhi Road, New Delhi-110003.
- iii) **The last date of submission of application under the EOI is 09th August 2018 before 1500 hrs(IST).**
- iv) Application received after the closing of EOI will not be entertained.
- v) Application received through FAX & email will not be entertained. Only application received in the tender box will be considered.
- vi) Application incomplete in any form or mis-statement of facts will be rejected.
- vii) It will be preferable if the application for separate products / commodities be submitted in separate envelopes.

4. The empanelled manufacturer shall accept all the terms & conditions of the project authority / importer and in case of order shall, on back to back basis deliver the said products and commodities to the customer / importer in the manner required at the nominated destination. The payment shall be made to the Associate after the receipt of the same from the project authority.

5. Place for submission of Expression of Interest:

The Expression of Interest should be addressed to Shri N. Vijaya Kumar, Dy. Manager, 3rd floor, MMTC Limited, Core -1, SCOPE Complex, Lodhi Road, New

Delhi-110003 and is to be submitted along with duly filled in annexure and enclosures before **1500 hrs IST on 09.08.2018**.

6. General Terms & Conditions :

- i) MMTC reserves the right to accept or reject any offer of EOI without assigning any reason whatsoever.
 - ii) Final selection of manufacturer from the EOI received will be done by MMTC at its sole discretion and the decision of the MMTC shall be final and binding on the empanelled parties.
 - iii) Selection in the panel at no point of time guarantees any award of work by MMTC through this empanelment and the manufacturer who fails to get the opportunity shall not have any right to claim any damages whatsoever against MMTC.
7. The prospective associate manufacturer may clearly note that the terms & conditions enumerated for this EOI which only illustrate and not exhaustive. The chosen manufacturer from the panel will have to enter into separate contracts as advised by MMTC to fully protect MMTC's interest and also interest of the project authority.
8. The prospective associate manufacturer can also be asked to furnish additional information/confirmation in connection with verification of the documents submitted by them if deed necessary.
9. Additional information/corrigendum/Addendum regarding EOI process shall be posted on MMTC website www.mmtclimited.com and GOI's website www.eprocure.in only from time to time. No press advertisement shall be issued for the updation/corrigendum/addendum. Prospective associate manufacturer are therefore advised to regularly visit above websites to update themselves.
10. Ownership of EOI document and information therein of EOI documents will become the property of MMTC upon submission. Whether the prospective associate manufacturer believes that information provided in response to this EOI is or shall be kept confidential or disclosure of this information would unreasonably affect associate manufacturer 's business affairs, notice is to be given at the time of delivery of the information or documents by clearly marking such information as "confidential". In order to practicable MMTC will give effect to the prospective associate manufacturer stated wishes and request for access to such information will be determined under the RTI Act.

11. No contractual obligation :

MMTC is not bound contractually or in any other way to any prospective associate manufacturer to this EOI. MMTC is not liable for any cost or compensation in relation to the consideration of this EOI or any EOI, incurred by the prospective associate manufacturer to this EOI whether or not MMTC terminates, varies or suspense the EOI process or take any other action permitted.

12. Short listing of manufacturers :

Prospective bidders who qualify as associate manufacturer to MMTC would be individually notified after the evaluation process is complete. The validity of the EOI shall be for a period of 2 years from the date of acceptance by MMTC which shall be renewed by a further period of one year at the sole discretion of MMTC.

13. MMTC reserves the right to add/delete in the associate manufacturer in the list of empanelled associates at its sole discretion.

14. Disclaimer :

Issue of this document does not in any way commit or otherwise oblige MMTC to proceed with all or any part of the EOI processed. The EOI request is not the subject of any processed contract or any contractual obligation between MMTC and the prospective bidder. MMTC may at its absolute discretion, elect to abandon any part or whole of the process without giving prior notice to the prospective Associate Manufacturer.

15. ARBITRATION

Any dispute or difference whatsoever arising between the parties out of or relating to the construction, meaning, scope, operation or effect of this EOI or the validity or the breach thereof shall be settled by arbitration in accordance with the Rules of Arbitration of the Indian Council of Arbitration, New Delhi and the Award made in pursuance thereof shall be binding on the parties. The seat for Arbitration shall be New Delhi.

16. Jurisdiction

The applicants hereto agree that the Courts and Tribunals at New Delhi shall have exclusive jurisdiction to settle any or all disputes which may arise out of or in connection with this EOI. All disputes arising out of this EOI shall be decided in accordance with the Laws of India.
