The bids shall be opened on the same day ie., on 16th December 2021 at 3.30 P.M. Decision of MMTC Limited will be final and binding on the bidders. MMTC Limited reserves the right to accept or reject any / all quotations without assigning any reason whatsoever.

2) EARNEST MONEY DEPOSIT (EMD) (Non-interest bearing):

a) E-Bid shall be accompanied by an EMD of Rs.5000/-. The EMD payment shall be made by the bidders through the payment gateway which is integrated with our e-portal.

EMD amount has to be received by MMTC latest by 15.00 Hrs IST on 16/12/2021.

- b) EMD of the unsuccessful bidder(s) including those whose bid(s) are not accepted will be returned within ten (10) working days of closing of the tender.
- c) EMD of the successful bidder will be treated as security deposit and shall be returned only after the successful completion of entire sales contract after deduction of all charges, if any, due from them.

3) Inspection:

Vehicles/documents will be available for inspection from **25.11.2021 to 15.12.2021** between 10:30 AM and 04:30 PM (only on working days – Monday to Friday) in MMTC's regional office at **No.6 Esplanade, Chennai House, 2nd Floor, Chennai - 600108**. No counter conditions or relaxations of conditions mentioned in tender will be accepted.

4) Submission of E-bids:

The Bids are to be submitted in Electronic form only and the complete set of bid documents along with Annexures A, B & C are to be uploaded in electronic mode. Tender documents & Annexures duly stamped & signed as a token of acceptance of all terms and conditions of the tender is to be uploaded along with required documents.

Procedure/guidelines for E Bidding is given at Annexure C.

The E-bid is to be uploaded on electronic mode latest by 15:00 Hrs IST on 16.12.2021

The EMD payment shall be made by the bidders through the payment gateway which is integrated with our e-portal on or before tender closing date i.e.,16.12.2021 latest by 15:00 hrs IST and received by MMTC.

The bids shall be **opened at 15.30 Hrs. IST on 16/12/2021** at MMTC, Regional office, Chennai.

The following may also be complied with:

- Each page/document must be signed by the bidder.
- Offer(s) incomplete or deficient, received late and/or not accompanied by valid EMD shall not be accepted.
- Highest offer duly filled up for the vehicle listed for sale shall be considered. However, MMTC reserves the right to accept or reject any or all bids wholly or partially or make counter offer for the bid(s) without assigning any reasons thereof.

5) Opening of the Bid

E-Bids will be opened on 16.12.2021 at 3:30 pm. Bids in respect of bidders who have remitted EMD shall be opened.

6) Acceptance

MMTC Limited reserves the right either to accept or reject any/all offers at its discretion. After offers are opened, sale may be postponed or cancelled by MMTC Limited at its discretion if the bids are found unsuitable. MMTC also reserves the right to further negotiate with highest bidder. Highest successful bidder will have to deposit 25% of the final bid value by way of e-payment / online payment on the next working day of issuance of letter of acceptance and the balance payment shall be made within five working days failing which the EMD and 25% of the bid shall be forfeited.

7) MMTC Employees cannot participate in the tender.

8) Tax / Insurance etc., :

All applicable Taxes will be levied by MMTC Limited and Payable by the bidder over and above the bid price.

9) Possession:

On receipt of 100 % payment from the bidder, Sale letter will be issued in the name of the Bidder under whom offer is made. Delivery of Vehicle should be taken from MMTC Premises within four working days of handing over of sale letter. In case delivery of vehicle is not taken after four days, penalty will be charged at the rate of Rs. 200/- per day upto 15 days. Thereafter, MMTC Limited at its discretion may cancel the sale and shall forfeit the entire amount deposited by the bidder. No complaint will be entertained in this matter and the vehicle will be disposed through fresh tender.

It will be the responsibility of the purchaser to get the vehicle transferred in his name. N.O.C, if necessary shall be given by MMTC. Set of Documents for RTO transfer has to be signed by the Purchaser in presence of The Additional General Manager, MMTC Limited, Regional Office before physically taking delivery of the vehicle from MMTC's Premises.

10) Documents constituting Contract:

The invitation of Bids, the terms and conditions of e-tender, Bid of the successful bidder, Letter of acceptance & Sale letter issued by MMTC Ltd. along with any amendment issued thereto shall constitute the contract between MMTC Ltd. and the successful bidder.

11) Indemnity:

The Bidder shall keep MMTC indemnified at all times against any claims/ liabilities/ proceedings etc., from any third party or otherwise arising out/ or in connection with this Tender.

12) Arbitration Clause:

Any dispute or difference whatsoever arising between the parties out of or relating to construction, meaning, scope, operation or effect of this contract or validity shall be settled by arbitration in accordance with the Rules of Arbitration of the Arbitration & Conciliation Act 1996, the award made in pursuance thereof shall be binding on the parties. The venue of Arbitration will be Chennai.

13) Force Majeure:

Should any of the force majeure circumstances, namely act of God, natural calamity, fire, Government of India policy, restriction, strikes or lock-outs by workmen, war, military operations of any nature and blockades preventing MMTC/successful bidder from wholly or partially carrying out their contractual obligations, the period stipulated for the performance of the contract shall be extended for as long as these circumstances prevail, provided that, in the event of these circumstances continuing for more than three months, either party shall have the right to refuse to fulfill its contractual obligations without title to indemnification of losses it may thereby sustain. The party unable to carry out its contractual obligations shall immediately inform the other party of the commencement and the termination of the circumstances preventing the performance of contract. A certificate issued by the Competent Government authority / respective Chamber of Commerce shall be sufficient proof of the existence and duration of such circumstances.

14) Fraud Prevention Policy:

- (1) Commitments of the Bidder(s)/ Contractor(S)/ Buyers(s) / Vendor(s): The Bidder(s)/Contractor(S)/Buyers(s)/Vendor(s) shall be bound to take all measures necessary to prevent Fraud and Corruption while dealing with MMTC. They agree and undertake to observe the principles/provisions as laid down in "Fraud Prevention Policy" of MMTC(Full text of which is available on MMTC's website at www.mmtclimited.com during their participation in the tender process, during the execution of contract and in any other transaction with MMTC. The Bidder(s)/Contractor(S)/Buyers(s)/Vendor(s) shall not, directly or through any other person or firm, offer, promise or give or otherwise allow any of MMTC's employees any material or other benefit which he/she Is not legally entitled to, in order to obtain in exchange any advantage of any kind whatsoever during the tender process or during the execution of the contract. The Bidder(s)/Contractor(S)/Buyers(s)/Vendor(s) shall not enter with other Bidders into any undisclosed agreement or understanding, whether formal or informal. This applies in particular to prices, specifications, certifications in the bidding process. The Bidder(s)/Contractor(S)/Buyers(s)/Vendor(s)shall not commit or allow any employees of MMTC to commit any offence under the relevant provisions of IPC/Prevention of Corruption Act: further the Bidder(s)/Contractor(S)/Buyers(s)/Vendor(s) will not use improperly or allow any employee(s) of MMTC, for purposes of competition or personal gain or pass on to others, any information or document provided by MMTC as part of the business relationship, including information contained or transmitted electronically. The Bidder(s)/Contractor(S)/Buyers(s)/Vendor(s) shall not instigate third persons to commit offences/activates outlined in Fraud Prevention Policy or be any accessory to such offences. The Bidder(s)/Contractor(S)/Buyers(s)/Vendor(s) if any possession of any information regarding fraud/suspected fraud, hereby agree and undertake to inform MMTC of same without any delay.
- 2. Disqualification from tender process and exclusion from future contracts: IF the Bidder(s)/Contractor(s)vendors, before award or during execution has committed a transgression through a violation of Clause 16(1) or "Fraud Prevention Policy" of MMTC in any other form such as to put their reliability or credibility in question, MMTC other than taking recourse available under law, shall be entitled to disqualify Bidder(s)/Contractor(S)/Buyers(s)/Vendor(s) from undertaking any transaction with MMTC and/or declare the bidder(s)/contractor(s) ineligible to be awarded a contract either indefinitely or for a stated period of time.
- (3) Damages: If MMTC has disqualified the Bidder(s) from the tender process prior to the award or during execution according to this Clause, MMTC shall be entitled to demand and recover from the Contractor liquidated damages of the Contract value or the amount equivalent to Security Deposit/EMD.
