#### 1. INVITATION FOR E-BIDS:

MMTC Limited, Regional Office, 6, Esplanade, "Chennai House", Chennai – 600108 invites **E-bids** from Individuals & Firms in Chennai intending to purchase used office items on "**As is where is basis and no complaint basis**" on the terms and conditions given below:

Interested parties may upload their E-BIDS (electronic form only). The last date for receiving the e-bids is 3<sup>rd</sup> February 2023 upto 3.00 P.M. The bids shall be opened on the same day ie., on 3<sup>rd</sup> February 2023 at 3.30 P.M. Decision of MMTC Limited will be final and binding on the bidders. MMTC Limited reserves the right to accept or reject any / all quotations without assigning any reason whatsoever.

#### TERMS AND CONDITIONS ARE AS FOLLOWS:

1. **Product**: Various used office furniture items, Air conditioners, Vaults and other miscellaneous items. Details are given at Annexure-I. The items are offered on "As is where is basis and no complaint basis".

The used items are broadly classified into 3 categories as follows:

Category 1: Various used office furniture items and miscellaneous items (These items are available in 2 locations).

Category 2: Used Air-conditioners (Spilt ACs and Window ACs) – (These items are also available in 2 locations).

#### **Category 3: Used Vaults**

The bidder may apply for any of the above category or all of the above category items. While applying for each category, all items listed under that category has to be taken by the bidder and hence bid has to be submitted for all the items in that category **in total.**

#### 3. Delivery: Ex – Above addresses mentioned at Point 2:

a) **LOA** (**Letter of Acceptance**) will be issued by MMTC to the highest successful bidder in each category and the delivery date will be indicated in the letter. Delivery will not be given prior to that date. At the time of taking delivery of items from the above 2 locations, Successful bidder shall arrange for handling, shifting & transportation of the items at their own cost under prior intimation to MMTC.

The successful bidder / bidders to whom the LOA has been issued can take delivery on the date specified in the Letter of Acceptance. The bidder cannot take delivery prior to that date.

- b) Payment Terms: The highest successful bidder in each category has to remit the payment as follows:
  - Seventy Five percent (75%) payment has to be remitted by the successful bidder for the allotted items within 2 working days of receipt of LOA.
  - Balance payment shall be made by the bidder 2 days prior to the date of delivery as per LOA. The date on which the bidder is allowed to take delivery will be mentioned in the Letter of Acceptance.
- c) Lifting time The allotted items should be strictly lifted on the delivery date indicated in the LOA. In case of any delay in lifting on the delivery date, suitable penalty will be imposed on the successful bidder.
- d) **Handling, Loading and Transportation charges** from the above 2 locations shall be borne by the successful bidder.
- e) All Items shall be delivered on "As is where is basis and no complaint basis"
- f) Delivery Challan shall be issued by MMTC as per the allotment. The items offered for sale are listed in Annexure-I. However, MMTC reserves the right to retain any item from the list if it so desires at the time of delivery. The cost / price remitted by the bidder to that extent will be refunded to him and the bidder cannot make any claim in this matter.
- 4. Validity: Bids must remain valid for 90 days (Ninety days) from the date of opening of price bid.

- **6.** EARNEST MONEY DEPOSIT (EMD) (Non-interest bearing):

- d) The EMD shall not carry any interest.

- Highest offer duly filled up for each category of used items listed for sale shall be considered. However, MMTC reserves the right to accept or reject any or all bids wholly or partially or make counter offer for the bid(s) without assigning any reasons thereof.

#### 8. Opening of the Bid

E-Bids will be opened on **3.2.2023 at 3:30 pm**. Bids in respect of bidders who have remitted EMD shall be opened.

- **9. PRICE**: Price to be quoted in Rupees as per Bid Format at **Annexure B.** All taxes and duties are to the account of buyer as applicable. **The Bidder has to quote the individual rates and the total rate as indicated in Annexure B.**
- **10. Title and Risk** MMTC shall retain title and ownership of the material until issuance of D.O and until receipt of the final amount including interest, if any, from the party.
- **11. Award of Contract** MMTC shall award the contract to the highest successful bidder (H1) in each category. Letter of Acceptance (LOA) shall be issued to the successful bidder detailing the terms of the tender.

#### 12. DUE DATES:

#### 13. GENERAL CONDITIONS

- Bidders can apply for any category items or all category items, however, all items listed under that "particular" category has to be taken by the bidder and hence bid has to be submitted for all the items in that category **in total.**
- MMTC shall confirm the acceptance of price to the highest bidder (H1) but reserves the right to cancel the bids at any stage. The highest bidder in each category shall initially make Seventy Five percent (75%) payment for the allotted items within 2 working days of receipt of LOA and the balance payment shall be made by the bidder 2 days prior to the date of delivery. The date on which the bidder is allowed to take delivery will be mentioned in the Letter of Acceptance.
- In the event of non execution or non lifting of entire quantity by the successful bidder, MMTC reserves the right to sell the material to H2 bidder and the successful bidder cannot make any claim.
- MMTC reserves the right to modify and amend the terms & conditions and announce the same at any time before the tender concludes. Announcements during the tender by facts including announcement of any additional conditions or correction in the tender including quantity are binding on the bidder. MMTC also reserves the right to extend the tender due date at its discretion.
- MMTC reserves the right to accept or reject any or all bids or to re-tender at MMTC's sole
  discretion without assigning any reasons. Incomplete offer, offers received without EMD,
  offers received after the closing time and date shall not be accepted.
- The successful bidder has to take delivery only on the date specified in the LOA from the 2 locations at his own cost.
- At anytime before issuance of D.O., MMTC has the right to cancel the allotment without assigning any reasons.
- **14.** Cancellation of Contract If the successful bidder(s) fail to fulfill their contractual obligations for reasons other than Force Majeure, MMTC shall be entitled at its own option to cancel the contract and recover the damages in addition to forfeiture of EMD and payment made. MMTC shall not be liable to any risks and costs, whatsoever, consequent upon such cancellation of the contract.
- **15.** Tax All applicable Taxes will be levied by MMTC Limited and Payable by the bidder over and above the bid price.

#### 16. FRAUD PREVENTION POLICY:

Commitments of the Bidder(s) / Contractor(s) / Buyer(s) / Vendor(S): The Bidder(s) / Contractor(s) / Buyer(s) / Vendor(S) shall be bound to take all measures necessary to prevent Fraud and Corruption while dealing with MMTC. They agree and undertake to observe the principles/ provisions as laid down in "Fraud Prevention Policy" of MMTC (full text of which is available on MMTC's website at www.mmtclimited.gov.in during their participation in the tender process, during the execution of contract and in any other transaction with MMTC.

(a) The Bidder(s)/Contractor(s)/Buyer(s)/Vendor(S) shall not, directly or through any other person or firm, offer, promise or give or otherwise allow any of MMTC's employees any material or other benefit which he/she is not legally entitled to, in order to obtain in exchange any advantage of any kind whatsoever during the tender process or during the execution of the contract.

- (b) The Bidder(s)/Contractor(s)/Buyer(s)/Vendor(S) shall not enter with other Bidders into any undisclosed agreement or understanding, whether formal or informal. This applies in particular to prices, specifications, certifications, subsidiary contracts, submission or non-submission of bids or any other actions to restrict competitiveness or to introduce cartelization in the bidding process.
- (c) The Bidder(s)/Contractor(s)/Buyer(s)/Vendor(S)shall not commit or allow any employees of MMTC to commit any offence under the relevant provisions of IPC/Prevention of Corruption Act; further the Bidder(s)/Contractor(s) Buyer(s)/Vendor(S) will not use improperly or allow any employee(s) of MMTC, for purposes of competition or personal gain, or pass onto others, any information or document provided by MMTC as per of the business relationship, including information contained or transmitted electronically.
- (d) The Bidder(s)/Contractor(s)/Buyer(s)/Vendor(S) shall not instigate third persons to commit offences/activities outlined in Fraud Prevention Policy or be an accessory to such offences.
- (e) The Bidder(s)/Contractor(s)/Buyer(s)/Vendor(S) if in possession of any information regarding fraud/suspected fraud, hereby agree and undertake to inform MMTC of same without any delay.
- (2) Disqualification from tender process and exclusion from future contracts: If the Bidder(s)/Contractor(s), before award or during execution has committed a transgression through a violation of this Clause, above or "Fraud Prevention Policy" of MMTC in any other form such as to put their reliability or credibility in question, MMTC other than taking recourse available under law, shall be entitled to disqualify the Bidder(s)/ Contractor(s) Buyer(s)/ Vendor(S) from undertaking any transaction with MMTC and/or declare the bidder(s)/contractor(s) ineligible to be awarded a contract either indefinitely or for a stated period of time.
- (3) Damages: If MMTC has disqualified the Bidder(s) from the tender process prior to the award or during execution according to this Clause, MMTC shall be entitled to demand and recover from the Contractor liquidated damages of the Contract value or the amount equivalent to Security Deposit.

#### 17. HOLIDAY-LISTING:

Notwithstanding anything contained in this agreement, MMTC's policy for Holiday-Listing of an Agency mutatis mutandis applies to this agreement and in the event, the agency(s) while discharging its obligations under the Agreement or otherwise, come(s) within the ambit of the said policy, MMTC at its sole discretion reserves the right to suspend/discontinue dealing or take any curative measures with the agency(s) in accordance with the policy in force.

#### 18. FORCE MAJEURE

- 1. During continuance of the Contract, MMTC shall not be held liable or responsible for any loss, claims or demand of any nature whatsoever, and shall not be deemed in breach of the contract because of any delay or failure in observing or performing any of the conditions or provisions in whole or part thereof, if such delay or failure is caused by or arises out of any circumstances whatsoever beyond Agency's control including (but without limiting the generality of the foregoing) declared or undeclared war, hostility, civil commotion, quarantine, sabotage, blockade, revolution, police action, riots or disorders, embargoes or trade restrictions of any sort, Government or quasi Government action, acts of God, fire, flood, earthquakes, storms, tides or tidal waves, explosion, accident, radiation, strike, lockouts, or other disputes or epidemic.
- 2 If by reason of any cause beyond the control of Agency there is any curtailment or suspension of services, then MMTC shall be excused from the obligations to that extent and MMTC shall not be bound to arrange delivery/ services by way of hiring or otherwise from other sources.

- 3. If the operation of such conditions continues to exceed three month, either party shall have the right to refuse further performance of the agreement in which case neither party shall have the right to raise any claims/damages.
- 4. The party which is unable to fulfill its engagement shall immediately inform the other party of the existence and of the termination of the circumstances preventing the performance of their obligation.
- **19.** All dispute or differences whatsoever arising between the parties out of or relating to the construction, meaning and operation or effect of this contract or the breach thereof shall be settled by amicable settlement between the parties. However, if settlement doesn't work out then the decision of MMTC, RO In charge shall be final.

#### **20. DISCLAIMER:**

MMTC may at its absolute discretion, shortlist, accept, disqualify, elect to abandon, reject any part or whole of the process without giving prior notice to the prospective party. MMTC reserves the right to cancel the Tender in totality without assigning any reason at any point of time. All information contained in this tender is issued bonafide.

#### **21. INDEMNITY** :

The Bidder shall keep MMTC indemnified at all times against any claims/ liabilities/ proceedings etc., from any third party or otherwise arising out of/ or in connection with this Tender.

**22.** If in case, the name of MMTC is engraved or marked on any office item, the Bidders should not misuse the name of MMTC in any way for any material benefit.
