Terms and conditions

- 1. Tenders must accompany an EMD amount of Rs. 55,000.00 (FIFTY Five Thousand Only)through DD favoring MMTC Ltd. payable at AHMEDABAD, for each location. Unsuccessful tenderers shall be refunded the EMD amount after finalization of the tender process or location visits whichever occurs earlier.
- 2. Offers received from Brokers and incomplete offers will not be entertained.
- 3. Offers submitted shall remain valid for a period of 90 days from the date of tender opening.
- 4. Contact No. & Details of only legal owners / legal power of attorney holders to be furnished, wrong details or details other than the legal owner/ legal power of attorney holder shall summarily cancel the tender and forfeit the EMD amount.
- 5.The Location of the proposed MMTC Showroom should be on Shivranjani crossroad/ C G Road / Satellite Road and should be visible from the main Road in order to enhance the visibility of MMTC Showroom.
- 6. It should have a separate cabin for official work.
- 7. The carpet area should be approx 1000 sq ft.
- 8. It should be fully furnished preferably with CCTV cameras and counters fit for jewellery and sanchi silverware / medallion display
- 9. It should have a strong room/vaulting facility indoors.
- 10. There should be easy access to the showroom.
- 11. It Should be in the vicinity of major established jewellery showrooms
- 12. It Should have neat and clean and ventilated washroom and western toilet facilities for ladies and gents.
- 13. Tenders received from locations other than specified above shall be rejected at the time of opening the technical bid.
- 14. Permission for any addition or alteration of the built up space offered, to convert it in to a Gold jewellery showroom, if required, from any authority shall be the responsibility of the Owner at his all cost and risk.
- 15. Facilities of electricity supply connection & water supply connection up to the built-up space shall be to the owner's account however, its consumption charges shall be paid by MMTC as per the actual bills received from the concerned departments.
- 16. Any penalty imposed on the owner by any authority at any stage during the lease period or at time of sale because of the wrong / illegal construction, property tax or any other statutory tax evasion on the part of the property or owner shall be to the owners account. Any disruption in showroom operations due to this shall make the owner liable to pay losses to the MMTC occurred due to the above act of the owner.
- 17. Built up space offered must have the approval of the appropriate authority for commercial usage.
- 18. All the statutory payments / taxes related to the property of arrears, if any, shall be to the owners account and MMTC shall not be liable for any such payment at any stage.
- 19. MMTC shall pay all-inclusive rent only to the owner through e-payment.
- 20. Lease agreement to be signed by the legal owner.
- 21. EMD must be submitted with technical bid.
- 22. MMTC reserves the right to reject any or all the offers without assigning any reason thereof
