APPOINTMENT OF INDEPENDENT INSPECTION AGENCY AT PPT PLOT / PICTPL PLOT, PARADIP PORT FOR MS BILLETS EXPORT

MMTC Limited, A Government of India Enterprises, Regional Office at Bhubaneswar, Alok Bharati Complex, 7th Floor, Shahid Nagar, Bhuaneswar-751007, Odisha, India (here in after called the Principal/Owner) invites sealed open Tender in two bid system(Technical Bid & Price Bid) for rake sampling , analysis and quality control of Billets Rakes as well as Draft Survey and analysis for export of Billets Vessel etc on the terms and conditions as per the Annexure I:

The bidder(s) are required to submit their sealed tender on 17th May 2019 by 15.30 Hrs at MMTC Limited, Alok Bharati Complex, 7th Floor, Shahid Nagar, Bhuaneswar-751007, Odisha, India.

The offer(s) is / are required to be submitted in two separate sealed envelops i.e. one for Technical Bid and another for Price Bid, duly signed in each page containing documents mentioned. The **Technical Bid** will be **opened on 17th** May 2019 at 16:00 Hrs and Price Bid of technically qualified bidders will be opened subsequently. The Authorized Representatives of the bidders may witness the process, if desired so.

TERMS AND CONDITIONS ARE AS FOLLOWS:

1. Eligibility Criteria

- i. Has establishment at Paradip, Odisha to carry out the said operation.
- ii. Has undertaken similar work (Export of Billets or Steel Products) for large/ medium organizations in last 3 years, at Paradip Port/ major port in India.
- iii. Experience in IIA activities of Steel or Steel Products for exports.
- iv. IIA shall have satisfactory/dispute free performance during last 03 (three) years (2015 onwards) with MMTC/NINL/any other PSU/any other reputed organization. In case of any incident of dispute/misdemeanor which caused damage/risks to MMTC/NINL/any other PSU/any other reputed organization in the past, such Bid shall not be entertained.
- v. Should have valid IIA License in the names of Bidder and have permission from Customs, Paradip / its jurisdiction.
- vi. Should have GST Registration in the state Odisha.



2 . EMD/PBG:

Bidder should deposit EMD of Rs 10,000/- in shape of DD from a Nationalized bank in favor of MMTC Limited payable at Bhubaneswar or transfer online to MMTC Account No. 10229909115 State Bank of India, Commercial Branch, Bhubaneswar ,IFS Code SBIN0006657. In case of online transfer, the copy of account statement showing transfer of EMD should be enclosed with technical bid in place of DD. Unless the amount is credited before the opening of Technical bid to said MMTC A/C the bid is not eligible and will be cancelled.

The EMD amount will be refunded to unsuccessful bidders. The amount will be retained as performance Guarantee of L-1 bidder/bidders and refunded after successful completion of awarded work without any interest.

4. Mode of Submission:

The bids(s) is / are to be submitted in following manner:

- b. Price Bid: In Price Bid format as Annexure- II
- c. Mandatory information as per Annexure –III & IV to be submitted(duly signed & stamped) in technical bid.

Both the above envelopes containing Techno Commercial Bid and Price Bid in Part –I & Part-II, shall be put in another envelop super scribing "Tender NIT NO. MMTC/BBSR/IIA/MS BILLETS/2019-20/01 dated 29.04.2019 FOR SAMPLING & ANALYSIS WORKS FOR MS BILLETS EXPORT."

4(A). Due date for submission:

The last date & time for submission of two bid tender along with above documents is 15.30 Hrs on 17th May 2019 and opening of the same at 16:00



Hrs on the same day. The rates quoted by the bidders in the tender will remain valid for 60 (sixty) days from the date of opening the tender. There should not be any indication/mention of prices in the technical bid (part-1) and if the same is found in part -1, the same will be summarily rejected. Hence, the prices quoted must be mentioned in the price bid (part-II) only.

5. AWARD OF CONTRACT:

The MMTC Limited, RO, BBSR shall award the contract to the Lowest Bidder (L1) by taking cumulative price bids of all functions.

6. Tenure of the Contract:

The contract will be valid for two years ie. from May-2019 to 31-05-2021 and further may be extended for another one year with same L/1 price, depending upon the performance of the bidder with same terms and conditions.

7. TERMS OF PAYMENT:

Original Bills in triplicate will be sent through MMTC, SRO, Paradip. The bills for rakes will be monthly basis with certificate contains R/R Nos & R/R date, No of wagons, time & date of unloading period, analysis both chemical & physical and assessed weight. The bills for vessel & stock verification will be case to case basis. MMTC will make payment online within a month from the date of receipt of the bills.

8. TAXES

The Bidder(s)/ Contractor(s) shall bear all statutory dues including taxes, duties, charges or levies that may be assessed, imposed or levied upon the Contractor(s) / bidder(s) in connection with the contract. Principal/Owner shall in no way be responsible for such taxes and duties. GST as applicable shall be paid by the Principal/Owner. Income Tax which the Principal/Owner may be required by law to deduct shall be deducted at source and the same shall be paid to the tax authorities on account of the Contractor(s)/ bidder(s) and the Principal/Owner shall provide the Contractor tax deduction certificate. Wherever necessary, Contractor(s)/Bidder(s) shall produce proof of above payments.



9. EXTENSION OF CONTRACT.

This contract is valid for two years ie. from dt.May-2019 to 31-05-2021. The Principal/Owner on its sole discretion may extend the period of contract for another one year on the same terms and conditions as embodied in the contract.

10. GENERAL TERMS AND CONDITIONS:

- a) MMTC reserves the right to accept/reject any or all the tenders submitted on whole or in part without any notice or without assigning any reason thereof. MMTC does not guarantee any quantity for export.
- b) MMTC may at its discretion empanel one or more contractor against this tender subject to matching L1 price.

11. TERMINATION.

If the Contractor(s)/ bidder(s) commit breach of any provisions of the Agreement, the Principal/Owner shall notify the Contractor(s)/ bidder(s) to remedy such breach within a reasonable period. If breach continues to occur, the Principal/Owner shall have the right to terminate the Agreement by giving notice within 15 days.

13. FORCE MAJEURE.

The Principal/Owner and the Contractor(s)/ bidder(s) shall not be in any way, liable for non-performance consequences if lock out, fire, riots, war or insurrection or restraints imposed by Government, at of legislature or other authorities. If operation of such circumstances exceed three months, either Party will have the Right to Refuse further Performance of the Contract in which case neither Party shall have the right to claim eventual damages."

14. ARBITRATION.

All dispute or differences whatsoever arising between the parties out of or relating to the construction, meaning and operation or effect of this contract or the breach thereof shall be settled by arbitration in accordance with the rules of Arbitration on the Indian Council of Arbitration Act, 1996 and the



venue of the arbitration will be at Bhubaneswar, Odisha. The sole Arbitrator shall be appointed by Regional Head of MMTC Limited, Regional Office, Bhubaneswar & the award made in pursuance there of shall be binding to the parties.

15. FRAUD PREVENTION

- 1. Commitments of the Bidder(s) /Contractor(s) /Buyer(s) /Vendor(S): The Bidder(s)/ Contractor(s)/ Buyer(s)/ Vendor(S) shall be bound to take all necessary measures to prevent Fraud and Corruption while dealing with MMTC. They agree and undertake to observe the principles/ provisions as laid down in "Fraud Prevention Policy" of MMTC (full text of which is available on MMTC's website at http://mmtclimited.gov.in(http://mmtclimited.gov.in/)/)during their participation in the tender process, during the execution of contract and in any other transaction with MMTC.
 - (a) The Bidder(s)/Contractor(s)/Buyer(s)/Vendor(S) shall not, directly or through any other person or firm, offer, promise or give or otherwise allow any of MMTC's employees any material or other benefit which he/she is not legally entitled to, in order to obtain in exchange any advantage of any kind whatsoever during the tender process or during the execution of the contract.
 - (b) The Bidder(s)/Contractor(s)/Buyer(s)/Vendor(S) shall not enter with other Bidders into any undisclosed agreement or understanding, whether formal or informal. This applies in particular to prices, specifications, certifications, subsidiary contracts, submission or non-submission of bids or any other actions to restrict competitiveness or to introduce cartelization in the bidding process.
 - (c) The Bidder(s)/Contractor(s)/Buyer(s)/Vendor(S)shall not commit or allow any employees of MMTC to commit any offence under the relevant provisions of IPC/Prevention of Corruption Act; further the Birder(s)/Contractor(s) Buyer(s)/Vendor(S) will not use improperly or allow any employee(s) of MMTC, for purposes of competition or personal gain, or pass onto others, any information or document provided by MMTC as per of the business relationship, including information contained or transmitted electronically.
 - (d) The Bidder(s)/Contractor(s)/Buyer(s)/Vendor(S) shall not instigate third persons to commit offences/activities outlined in Fraud Prevention Policy or be an accessory to such offences.



- (e) The Bidder(s)/Contractor(s)/Buyer(s)/Vendor(S) if in possession of any information regarding fraud/suspected fraud, hereby agree and undertake to inform MMTC of same without any delay.
- 2. Disqualification from tender process and exclusion from future contracts: If the Bidder(s)/Contractor(s), before award or during execution has committed a transgression through a violation of this Clause, above or "Fraud Prevention Policy" of MMTC in any other form such as to put their reliability or credibility in question, MMTC other than taking recourse available under law, shall be entitled to disqualify the Bidder(s)/ Contractor(s) Buyer(s)/ Vendor(S) from undertaking any transaction with MMTC and/or declare the bidder(s)/contractor(s) ineligible to be awarded a contract either indefinitely or for a stated period of time.
- 3. **Damages**: If MMTC has disqualified the Bidder(s) from the tender process prior to the award or during execution according to this Clause, MMTC shall be entitled to demand and recover from the Contractor liquidated damages of the Contract value or the amount equivalent to Performance Bank Guarantee.

16. HOLIDAY LISTING:

Notwithstanding anything contained in this agreement, MMTC's policy for Holiday-Listing of an Agency mutatis mutandis applies to this agreement and in the event, the agency(s) while discharging its obligations under the Agreement or otherwise, come(s) within the ambit of the said policy, MMTC at its sole discretion reserves the right to suspend/discontinue dealings or take any curative measures with agency (s) in accordance with the policy in force.



ANNEXURE A

SCOPE OF WORK

INSPECTION ACTIVITIES:

- 1) The Contractor / Bidder (Independent Inspection Agency herein after called IIA) will perform Sampling, Analysis, Supervision and Assessment of quantity by weight of MS Billets rakes unloading at PPT/PICTPL plot, Paradip port.
- 2) The IIA will carry out Pre-Shipment and Post-Shipment Supervision, Sampling Analysis (according to BIS (Bureau of Indian Standard) norms i.e PRODUCT MANUAL FOR Carbon Steel Cast Billets Ingots, Billets, Blooms & Slabs for Re-Rolling into Steel for General Structural Purposes According to IS 2830:2012) & Draft Survey of Billets export vessels and issue certificates required by Customs and LC negotiation.
- 3) The IIA shall carry out Stock Verification Work of Billets fit for export as well as unfit for export at PPT/PICTPL plot, Paradip port counting pieces annually or as and when required, and issue the requisite certificates.
- 4) The IIA shall keep close liaison and coordination with our SRO, Paradip, Railways, Port, Vessel Companies /Agents and obtain particulars regarding the arrival of Billets rakes and vessel berthing and sailing of nominated vessels and report to the Principal/ Owner.
