### **TENDER NOTICE FOR SALE OF AMMONIUM SULPHATE**

MMTC invites quotations in closed/sealed cover from the established wholesalers/Dealers for sale of **200 MT** Ammonium Sulphate for immediate delivery ex-works, NINL, Duburi, Odisha. The material is produced as a by-product at NINL Coke Oven Complex with Nitrogen-20.50% Min., Moisture-up to 1% and Colour- Off white.

- 2)The quotation is acceptable for full **200 MT** only. Quotation for quantity less than 200 MT shall be rejected. Quotation for quantity more than 200 MT shall be considered for 200 MT only.
- 3) Allotment of quantity shall be at the full discretion of MMTC. The successful bidder is to deposit 100 % value of the allotted quantity including taxes and duties as applicable **within two days** from the date of issuance of Letter of Acceptance.
- 4)The quotation showing the best price (basic) Per MT is to be submitted along with **EMD @ Rs.800/- PMT** in the form of DD/Pay Order/ RTGS/Fund Transfer in favour of MMTC Limited, Bhubaneswar. EMD shall bear no interest and shall be refunded after successful lifting of the allotted quantity by the bidder/s.
- 5) The allotted quantity has to be lifted within 7 days from the date of issue of delivery order or as decided by MMTC. Failure to lift the allotted quantity within the stipulated period without valid and sufficient reasons may entail forfeiture of EMD. The delivery shall be , ex-works by road on regular basis.
- 6) The price offered should be **valid up to 15 days** from the date of opening of Tender.
- 7). The bids should be submitted in two sealed envelopes separately. One is to be super-scribed as **“Price bid ’** & second is to be super-scribed as **‘Technical bid’**. In price bid rate Per MT is to be quoted whereas in technical bid copy of valid dealer license is to be enclosed along with **EMD** instrument/details and **VAT/CST registration certificate**. Both Price bid & technical bid put in one sealed envelope super scribing **“Tender for Ammonium Sulphate”** is to be submitted to this office in the above address. MMTC will not be responsible for any postal delay in receipt of the tender document
- 8.) The last date for submission of the quotation is **12.09.2013 (Thursday) up to 1500 hrs**. The quotations shall be opened at **1530 hrs** on the same day.
- 9) In case of Inter- State Sale Form ‘C’ to be submitted in advance or **6%** of the total value of the material to be deposited in the form of security before issuance of Delivery Order.
- 10) Parties who have not submitted complete Form ‘C’ as per MMTC’s requirement up to the quarter ended in March’ 13 towards past purchases shall not be eligible to participate in the tender.

MMTC reserves the right to accept/reject any/all quotations/quantity, fix its own price increase/decrease tender quantity, change the lifting period and/or cancel the tender etc, without assigning any reason thereof.
