MMTC Limited (MMTC) is a Government of India Enterprise (under the administrative control of Ministry of Commerce and Industry) with its Corporate Office at Core 1 Scope Complex,7 Lodi Road Institutional Area New Delhi-110 003 (hereinafter called 'MMTC'). The applications, in two part bidding system in the attached formats, must be addressed to Dr. A. P. Pre-Qualification Bids / Envelope-I shall be opened at **15:30 Hrs on 09.11.2015** in MMTC's office in the presence of bidder's representatives desirous to be present. Price Bids / Envelope II of only the qualifying Bidders shall be opened after **16:00 Hrs on 13.11.2015** in MMTC's office.

Successful bidder shall be required to furnish a performance guarantee bond either in the form of demand draft payable at New Delhi or in the form of Bank Guarantee (BG) amounting to INR Rs 1,00,000 (Rupees One Lakh). The format of BG shall be provided once the contract is awarded. The Performance Guarantee bond is to be kept valid for a minimum period of 6 months after expiry of the contract. Successful bidder shall also undertake to work exclusively for MMTC in Engineering products and Agro Commodities without handling similar assignment for any other Principal. MMTC reserves the right to reject the bids without giving any reasons thereof. Incomplete applications are liable to be rejected. All expression of interest documents will become the property of MMTC upon submission. 		2- Must be registered under Law of Nepal and in this context, copies of the following registration documents as under must be enclosed: (a) Tax Clearance Certificate. (b) VAT registration certificate. (c) Valid agency registration Certificate from the concerned office of Government of Nepal.	
		3- Should have trading experience preferably (in engineering products and agro products) and working as agent on behalf of overseas suppliers for supply of Engineering goods and Agro Commodities against tenders issued by nominated agencies of Government of Nepal for the last 3 (three) years.	
		4- Should submit the details of corporate clients for whom such work is being carried out on regular basis, with documentary evidence.	
		5- Should enclose the Audited Balance Sheets and Annual Reports for last three years.
