- 2. The rates quoted in the Financial Bid should be both in words and figures in prescribed format (Part 2) only, exclusive of taxes.

TERMS & CONDITIONS

- 1. The material shall be removed from 2nd Floor of MMTC Limited at F8-11, Jhandewalan Flatted Factories Complex, Rani Jhansi Road, New Delhi.
- 2. To acquaint themselves about the material, the bidders are requested to meet Sh. Daniel Xalxo, Chief Manager at the above mentioned address on working days from 29-08-2018 to 03-09-2018 from 9.30 a.m. to 4.30 p.m. (Telephone No.011-23623955).
 - 3. The successful bidder shall be required to follow all the labour laws, minimum wages act and other provisions for labour welfare applicable from time to time. Nothing extra shall be paid for the same.
 - 4. The successful bidder shall clear the site after removing material in all respect to the entire satisfaction of the Chief Manager (Admn.).
 - 5. All the dismantled and unserviceable material shall be removed outside the building by the contractor/bidder. Nothing extra shall be paid on this account.
 - 6. The work shall be executed in close cooperation with the Chief Manager (Admn.).
 - 7. The work shall be executed without any loss/damage to MMTC properties.
 - 8. The contractor shall be fully responsible for safety of his workers and in case any accident / mishap, the entire responsibility will be on the contractor.

9. TERMS OF PAYMENT

- i) A copy of PAN and GST Number has to be submitted alongwith the tender documents.
- ii) The contractor shall have to deposit an EMD of Rs.10,000/- in the form of Pay Order / Demand Draft in favour of MMTC Limited payable at New Delhi on any nationalized Bank with technical bid. The bid shall not be opened unless EMD of required amount as mentioned above is enclosed.
- iii) The highest bidder shall have to deposit another Rs.50,000/- within two days after opening of the tender in the form of Pay Order/Demand Draft in favour of MMTC Limited payable at New Delhi on any nationalized bank or through RTGS/NEFT to MMTC Account, falling which EMD amount shall be forfeited.
- iv) The successful bidder / contractor shall deposit the balance amount after adjustment of EMD of Rs.10,000/- and Rs.50,000/- through DD in favour of MMTC Limited within three days from the date of acceptance of bid, failing which the entire amount of Rs.60,000/- already deposited will be forfeited.
- v) The applicable GST will be charged as per the rules on the unserviceable material, applicable at the time of the auction of the material.

- vi) The contractor shall be allowed to take out the material only after making the payment in full as at (iii) above.
- 10. All the material to be disposed of can be inspected at site before submitting the bid.
- 11. The contractor shall arrange for safety provisions as per ISI recommendations, CPWD Code and instructions issued from time to time.
- 12. The contractor shall indemnify MMTC against the claim for compensation arising out of negligence.
- 13. The validity of the bid will be 30 days from the date of opening of the tender.
- 14. The material shall be disposed of on "AS IS WHERE IS BASIS" in one single lot.
- 15. The scraps have to be moved by the successful bidder at their own cost.
- 16. The rate should be quoted "As is where is basis" on Lumpsum.
- 17. The successful bidder should bring their own vehicle, manpower and any other materials needed to segregate, pack, load and move the materials.
- 18. Bidders cannot withdraw their offer once it is submitted to MMTC, Limited, New Delhi
- 19. EMD of unsuccessful bidder will be returned within a reasonable period.
- 20. EMD of the successful bidder will be refunded after completion of the contract.
- 21. The tender should be submitted in the Tender Box kept at Main Gate of MMTC Limited, F8-11, Jhandewalan Flatted Factories Complex, Rani Jhansi Road, New Delhi on or before 04-09-2018 upto 1500 hours and will be opened on 04/09/2018 at 1530 hours in the presence of the tenderer, whoever wishes to be present.
- 22. MMTC reserves the right to accept or reject the offer without assigning any reason thereof.
- 23. The successful bidder will have to remove all the material by 11-09-2018 of deposit of balance amount as indicated in SI. No. 9(iii). Staking/disposal of any material within the par free of 1 KM from MMTC Limited, F8-11, Jhandewalan Flatted Factories Complex, Rani Jhansi Road, New Delhi will not be allowed. In case the material is not removed within the above said period, it will attract liquidated damage @ Rs.2,000/- per day.

24.
