SCOPE OF WORK

1. Periodical/Monthly inspection/analysis of stocks of Pulses for Moisture and Weevils.
2. Submission of reports on monthly basis.
3. Identifying the stocks which need fumigation.
4. Identify the conditions of PP Bags in which material is stored.
5. Analysis of Aflatoxin content on quarterly basis.
6. Regular physical inspection of the stocks to verify and suggest action required to maintain the quality of stocks.

Eligibility

The Bidder should have past experience of atleast 5 years of carrying out inspection of Pulses and accredited with NABL (National Accreditation for Testing and Calibration Laboratories) of India. A self attested certificate giving details of experience to this effect should be submitted by the inspection agency along with the NABL Certificate. The price bid is to be submitted through electronic mode only.

Submission of Bids:

Bidders shall submit their offers as per Annexure-I format (electronic form only) along with the E-Tender document duly signed in original and stamped on all pages of NIT confirming that the Bid is strictly as per terms of E-Tender enquiry and acceptance of all terms and conditions of the e-tender.
